**Subject: - Guidelines regarding Writer for Blind candidates.**

Dear Sir/Madam,

Appreciating the difficulties being experienced by the Blind students in engaging writer while taking various exam, the Vice-Chancellor in anticipation of approval of AC/EC has approved amendment in Clause 3 printed at Page No. 586 on the University Calender Volume-II (Part-B) (II-Conduct of Examinations (G) Special Arrangements for Amanuensis (Writer of Answers) regarding education qualification of a writer for blind as under: -

**“Criteria like educational qualification, marks scored, age or other such restrictions for the scribe/reader/lab assistant should not be fixed.”**

Accordingly, the above revised guidelines as also the instructions of Govt. of India issued vide Endst. No. CP-IV/14/43589-738 dated 05/08/2014 may be strictly adhered & implemented in letter & spirit.

Similarly to address the complaints of the blind candidates regarding misbehaviour with them in the Examination Centres, the Vice-Chancellor has taken a serious view of it & he has ordered that this be avoided henceforth.

It has also been brought to the notice of the Vice-Chancellor that the blind candidates are not provided extra time as admissible in rules to complete the examination. The Vice-Chancellor has ordered that necessary compliance of the earlier circulars in this regard be made strictly so as to overcome the difficulties being experienced by these blind students.
