

Subject: Carrying out urgent amendments in the University Prospectus for the academic session 2018-19.

Vide PUC-I, II & III, the Deputy Director Cadet Corps O/o the Director General Higher Education Haryana, Panchkula addressed to the Vice-Chancellors of all the concerned Universities situated in the State of Haryana (including KUK) has requested to take following action urgently:-

"In the light of ongoing bunch of CWPs 15399 of 2017 and other, please incorporate a provision in the prospectus of University with respect to the petitioner colleges wherein mentioning that the _____ (name of college) is affiliated to _____ (name of the University, vide notification dated 21.06.2017 but in view of the interim order of the Hon'ble Punjab and Haryana High Court, the _____ (name of college) is affiliation with _____ University subject to the final outcome of CWP No. 15399 of 2017 and others."

In this connection it is submitted that at present 4(four) C.W.Ps have been filed in Hon'ble High Court of Punjab and Haryana at Chandigarh by the concerned institutes/colleges against the Notification of the State Govt. dated 21.06.2017 for their shifting from Kurukshetra University, Kurukshetra to other Universities and as per interim order of the Hon'ble Punjab and Haryana these Colleges/Institutes are affiliated with Kurukshetra University, Kurukshetra.
