In supersession of the Notice Endst. No. CT-III/21/16736-935 dated 09.02.2021, the Vice-Chancellor on the recommendations of the Committee has approved the following guidelines for smooth conduct of U.G./P.G. Odd Semester Examinations to be held in Feb/March, 2021:

- 1. The theory examinations of UG/PG courses commencing w.e.f. 01.03.2021 will be conducted in blended mode.
- 2. Choice of mode i.e. offline/online will also be taken from the students by the Principal/Chairperson/Director of College/Department/Institute concerned. In offline Mode, the students will be allowed to take examination in their respective Institutes/Colleges. Necessary arrangements for the examination will be made by the concerned Director/Principal. Printed copy of the question paper & University Answer Book will be provided to the students to take their respective examination.
- 3. The practical examinations including Project Reports/Viva/Training/Dissertation etc. will be got conducted internally by all the concerned Chairpersons/Directors/Principals through online/offline mode before the commencement of the theory examinations.
- 4. The candidate will be required to attempt paper of 75% marks by choosing any question. However, the student shall ensure that he/she has attempted answers carrying 75% of maximum marks. The time allotted will be 3¼ hours (i.e. 09:30 AM to 12:45 PM in the morning & 1:30 PM to 4:45 PM in the evening) for examinations including time of downloading of question paper to sending the answer book to the concerned Chairperson/Director/Principal through Google Form.
- 5. The students who are suffering from COVID-19 or are having symptoms of COVID-19 will appear in the examination through online mode only.
- 6. The Foreign/other state students will appear through online mode.
