The Directorate has already uploaded tender on the website of the University as on 09.09.2021 and the advertisement have also appeared in The Tribune and Dainik Jagran on 11.09.2021 for inviting tender from different agencies upto 30.09.2021 for start of four online programmes through DDE w.e.f. July 2021 session.

In this regard it is submitted that the tender document could not uploaded on the "Haryana Government e-Tendering System" website due to non-availability of three class-3 Digital Signature Certificate (DSC) required for uploading tender of DDE on the "Haryana Government e-Tendering system".

- i) At present there are only two Digital Signature Certificate available with the University with valid period.
- ii) There are four active DSC available in the name of Kurukshetra University RUSA Project Society (KURPS).

In view of above, DDE may be allowed to upload the bid through KURPS e-tendering account. It is also requested to allow any amount collected/received from the bidders/agencies on account of this bid/tender and deposited in KURPS account be transferred in the bank account of Kurukshetra University, Kurukshetra.
