2. **General Category** is in fact the **Open** category that includes all General, SC, BC-A & BC-B category. You are directed to attend the counselling on 09.12.2010 at 10.00 A.M. to 12.00 Noon for admission to B. Ed. Part-I on the basis of Merit.

3. For this purpose, you are required to get the following **Original documents** checked:

- Certificate of qualifying Examination alongwith an attested copy (Matriculation onward).
- Teaching Experience Certificate, as required.

**(A candidate must submit proof of having COMPLETED 2 YEARS IN-SERVICE WORKING TEACHING EXPERIENCE AS ON 31.05.2010 only on the prescribed format given in the Prospectus (page-37) at Appendix-I. In case a candidate has served in more than one Institution (with/without break), he/she should use the photocopy of the proforma at Appendix-I for submitting the teaching experience certificates for each institution of service).**

- Category Certificate for which you have claimed **RESERVATION** along with an attested copy. **Backward class category candidates** are also required to submit an **Affidavit (Appendix-VII Page 43 of the Prospectus)** by their parents with regard to creamy layer.

- iv. Migration certificate or Affidavit duly attested by the Magistrate Ist Class in case of students who have passed their last examination from the University other than the Kurukshetra University, as per proforma given in the Prospectus at **page No. 46** at **Appendix-XII** to the effect that they will not be appearing in any other examination simultaneously from any other University during the session 2010-11.
  - v. **Complete Admission form/Examination Form in Original alongwith Computer Form and Identity Card (included in the Prospectus).**
  - vi. Character Certificate from the Head of the institution last attended OR from a Gazetted Officer/Sarpanch.
4. First installment of fee amounting to Rs.10, 000/- (Rs.5,000/- in case of SC/Blind Candidates) as prescribed in the Prospectus will have to be deposited immediately after getting the documents checked and after confirmation of your admission on the date of checking of the documents.
- The fee can be deposited either in cash direct at the counter of the **Oriental Bank of Commerce** in the premises of the University or through crossed **Bank Draft** drawn in favour of the Registrar, Kurukshetra University, payable at Kurukshetra/Thanesar from a bank having its branch at Kurukshetra/ Thanesar only. **However, it is advisable to bring fee in the form of Bank Draft.**
5. In case the above mentioned documents and fee are not received in this Directorate on the date you come for counselling, this offer of admission will automatically stand **CANCELLED** without any further notice and the seat will be offered to the next candidate in merit.
  6. If at any time subsequent to admission it is discovered that the information given in the application form or in the certificates attached by you is false, **OR** any misrepresentation/error/concealment/omission has been noticed, the admission will be cancelled ab-intio and all dues paid by you shall be forfeited.
  7. **Please note that no further extension in the date to deposit fee & documents, specified as above, will be allowed under any circumstances whatsoever. After depositing the requisite fee, Identity Card be obtained from the office in token of your admission.**
  8. Some students in waiting list with less percentage of marks have also been called to attend the counseling. Attendance will be marked on 09.12.2010 at 10.00 A.M. sharp for preparing merit list of present candidates to fill up remaining seat of B. Ed. (2 year) Part-I and in case any candidate with higher percentage turns up later, the Directorate would not be responsible.
