Minutes of the meeting of the Committee constituted by the Vice-Chancellor consisting of the following members held on 22.06.2020 at 12:00 Noon in the office of the Dean Academic Affairs to review the "Rules and Regulations for Promotion of Academic Integrity and Prevention of Plagiarism in Kurukshetra University".

The committee reviewed the existing "Rules and Regulations for Promotion of Academic Integrity and Prevention of Plagiarism in Kurukshetra University" and discussed the letter No. INFL/ShodhSudhi-PDS/2020/01 dated May 29, 2020. After deliberations the committee resolved the following:

- (i) The Plagiarism Detection Software URKUND will be used for the thesis/dissertation submitted in a language other than English. The use of URKUND will be applicable to the Ph.D. thesis submitting w.e.f. October 01, 2020 onwards and to the PG dissertations for the students taking admission in first year in the session 2020-21 onwards
- (ii) The librarian will conduct the workshops/training programs for all the stakeholders of the University for using plagiarism detection tools and creating awareness about plagiarism.
- (iii) Each supervisor and his/her student shall submit a certificate and undertaking respectively as per format provided in Annexure-I of the "Rules and regulations for Promotion of Academic Integrity and Prevention of Plagiarism in Kurukshetra University" circulated by academic branch vide no. ACS-II/19/2592-2668 dated Feb. 21, 2019.
- (iv) Other rules and procedures will remain same as circulated by academic branch vide nos. ACS-II/19/2592-2668 dated Feb. 21, 2019 and ACS-II/19/15626-15713 dated Aug. 19, 2019.
