In continuation of this office notification Endst. No. ACM-I/M-9/20/SpI.576-675 dated 16.04.2020 and further guidelines issued by the Principal Secretary to Govt. of Haryana, Higher Education Department, Panchkula vide order No. KW 18/79-2020 UNP(4) dated 03-05-2020, the Kurukshetra University shall remain closed till 17.05.2020 with the following conditions:

- 1. All the Deans/Chairpersons/Directors/Principals of the Faculties/UTDs/Institutes and Heads of the Non-Teaching Offices/Departments shall ensure that all the employees shall work from home. Further, the teachers and other staff shall be on duty at their respective home and be available when required.
- 2. All the Chairpersons/Directors/Principals of the UTDs/Institutes shall ensure the completion of the pending syllabus, if any with the help of only regular/contractual faculty by May 15, 2020 by devoting sufficient time for assignments/queries of the students through online platforms of teaching learning.
- 3. It will be ensured by the teachers that they shall assist in public communications in their respective areas. In emergent situations, the University authority may require the services of such employees at any time. Hence, all such employees working from home shall maintain headquarters and be in readiness for deployment at short notice and be available on landline/mobile phone.
- 4. No employee shall leave station without prior permission of the competent authority.
- During the defined period all the staff members shall follow the Government guidelines issued regarding precautions to stop spreading of COVID 19 and other guidelines issued time to time.

All the employees shall strictly abide by the Govt. guidelines referred above and the instructions already issued by the University vide notification(s) Endst. No. Gen/Steno/19/2200-2300 dated 19-03-2020, No. ACM-I/M-9/20/2730-2830 dated 23.03.2020; ACM-I/M-9/20/SpI.2831-2931 dated 26-03-2020 and No.ACM-I/M-9/20/SpI.576-675 dated 16.04.2020.
