Subject: Payment of Sports Registration Fee & Tournament Fee for the session 2020-21.

Sir/Madam,

Following fee are payable by Bank Draft in favour of Secretary, K.U.Sports Council, payable at Kurukshetra University, Kurukshetra .The Fee of the students be remitted in the office soon after the admission process is over .

Sports Registration Fee

- (I) Out of Rs.220/ per head per annum collected on account of Sports Registration Fee from each student at the time of admission, an amount of Rs.135 /- (Rupees one hundred thirty five only) per head per annum is to be sent in favour of Secretary, KUSC Rs. 85/- per head per annum shall be retained by the Government/ Non Government affiliated Colleges for their sports funds.
- (ii) In case of U.I.E.T, the whole amount of Sports Registration Fee i.e. Rs. 220/- (Rupees two hundred twenty only) per student per annum shall be sent to the Secretary, K.U.Sports Council.
- (iii) The University Teaching Department and maintained colleges of Kurukshetra University shall pay an amount of Rs.145/-(one hundred fourty five only) per head per annum to the Secretary, K.U.S.C and an amount of Rs. 75/- per head per annum shall be retained by the college for their Sports fund.
- (iv) The Technical Education Colleges/Institutes and affiliated to Kurukshetra University shall pay an amount of Rs.375/- per head per annum to the Secretary, K.U.S.C and an amount of Rs. 125/- per head per annum shall be retained by the college/Institutes for their Sports fund.

Note:- The above said fee is as per financial amendments approved by Executive Board KUSC and Kurukshetra University Sports Council in its Annual General body Meeting held on 22.07.2019 & 09.08.2019 respectively (Annexure-IV is enclosed).

Tournament Fee

- (v) Tournament Fee per annum on the basis of total students admitted in the College/Institutes are to be sent on the following rates:-
- (a) For colleges having total strength of students upto 200. Rs. 600/-
- (b) For colleges having total strength of students from 201 to 500. Rs. 2,000/-
- (c) For colleges having total strength of students from 501 to 1500. Rs. 4,000/-
- (d) For colleges having total strength of students from 1501 and above. Rs. 6,000/-

In addition to the above, a strength certificate as under is also to be sent along with Sports Registration Fee/Tournament Fee payment for audit purpose.

"This is to certify that the payment of Sports Registration Fee of Rs. _____ has been made @ Rs. ____ per head per annum for _____ students admitted in my college/Institution during the session 2020-21. The above said amount of Sports Registration Fee has been deposited accordingly and no balance is lying pending with this College/Institution on account of Sports Registration Fee".

- (vi) The colleges in arrear of Sports Registration Fee and Tournament Fee shall not be allowed to participate in the Inter Collegiate Tournaments until they clear their outstanding dues.
- (vii) Both the Fees (i.e Sports Registration and Tournament Fee) are payable to K.U.Sports Council irrespective of whether a college/Institution participates in the Tournaments/Sports Meet or not.
