NOTIFICATION

On perusal of the letters received from MHRD and Higher Education Department, Haryana and in order to combat the ongoing threat of spread of viral infection among the University fraternity and to protect it from Novel coronavirus COVID-19, it has been decided that Kurukshetra University will remain closed from March 23, 2020 to March 31, 2020.

During this period all faculty members, teachers, engaged floating faculty, researchers and non teaching staff (including contract, part time and outsourcing) shall work from home as a preventive measure against COVID-19 except essential services staff.

1. The work from home period shall be productively used by the faculty members/ teachers / researchers by;
 - i. Preparing study material and sharing with students through WhatsApp, email and other channels (Youtube, Piazza etc.).
 - ii. Share link of online resources to students.
 - iii. Giving assignments and projects to the students as per curriculum.
 - iv. Online support and counseling of students.
 - v. Engaging in research work.
 - vi. Developing curriculum as per 'Learning based outcomes'.
2. Each teacher shall maintain a record of daily academic activities during this period.
3. The employees shall be on duty from home and shall not leave station during this period.
4. All employees shall be easily reachable on mobile phones and email in case of any emergency contact and shall be ready to be present in the university at a short notice.
5. The employees shall create awareness about coronavirus and assist in university public communication as and when required.
6. During this period all employees shall take preventive measures as per government guidelines.
7. Employees shall check university website regularly for further updates.

These measures will be revisited on March 31, 2020.


