- 1. In the event of the Tender being submitted by a firm, it must be signed separately by each member thereof, or in the event of the absence of any partner, it must be signed on his behalf by a person holding a Power of Attorney authorizing him to do so.
- 2. In case, the contractor backs out to work or do not abide by the Contract Agreement, the earnest money deposited by him shall be forfeited besides any other action as may be considered necessary by the University authorities, Kurukshetra University, Kurukshetra.
- 3. The quantity may increase or decrease as the case may be.
- 4. The University authorities reserve the right to reject or accept any bid without assigning any reason.
- 5. All disputed shall be subject to jurisdiction of District Court, Kurukshetra.

Kurukshetra University was established in 1956 as a unitary residential University and its foundation stone was laid by late Dr. Rajendra Prasad, the first President of India. Located in the holy city of Kurukshetra, land of the historical battle of 'Mahabharata' and the great message of Bhagwad Gita, its campus is situated on the western bank of Brahm Sarover (the holy tank) and extends over an area of over 400 acres. Starting with only the Department of Sanskrit, it has grown into a multi-faculty University as one of the premier centres for advanced study and research in the region.

Kurukshetra University intends to avail the services of agency/firm capable of providing image based/AI based remote proctoring as mentioned in Financial Bid for various courses for the online examinations to be held from June to September 2021 so as to ensure the integrity of the appearing students and to maintain the sanctity of Examinations. Accordingly, bids are invited from remote proctoring solution providers that can provide Image based proctoring as a service to conduct the online examinations to the nearly 700 courses (on average four papers per course) numbering above two lacs students of the Kurukshetra University.

2. <u>SCOPE OF WORK</u>

The agency/firm shall provide the operational solutions for the conduct of the proctored blended mode(mixture of online & offline) Examinations (Descriptive Paper & Pen Examination) on the basis of the schedule to be conveyed by the Assistant Registrar (Conduct Branch), Kurukshetra University. The tentative number of students expected to appear in the Examinations to be held from June to September, 2021 will be 2 Lac (approx.) which may vary.

Remote Proctoring (AI & Human Proctoring) activity shall involve the activation of Remote Proctoring facility for the test takers. This should be on a Real Time basis but without compromising the credibility and sanctity of the test. Service provider/Bidder will be completely responsible for conducting the examinations.

The Remote Proctoring activity must have the following features:

- i. Establish candidate authentication; agency/firm to share the authentication process which will have to be mutually agreeable.
- ii. The Remote Proctoring facility should allow for human proctoring through Live Feed of the examination of each candidate. Solution should be able to work on the low internet bandwidth of 512 kbps. The Online exam should smoothly run on Android Mobile, desktop or laptop or any other similar device having net connectivity. The browser should be compatible with all modern Operating system.

- Familiarization of candidate to Remote Proctoring, Do's & Don'ts, Instructions etc.
 Bidder must have a provision in their solution of giving Mock/Trial test before the main examination.
- iv. Option to mandate candidate authorization by a remote authorizer before the candidate starts the test.
- v. Limit allocation of candidates to a proctor randomly and automatically.
- vi. Proctor should be able to validate the successful completion of the test.
- vii. Question Paper closing timing would be about four hours.
- viii. Paper-wise/Student-wise objectionable Images will be supplied by the firm/company to the concerned Evaluation Centres to be created by the University and the concerned Dept./Institute/College will check these objectionable images and will make Unfair Means Case, if necessary.
- ix. Invigilation during the exam:
 - The proctors will compare the facial recognition photo & the photo ID card and authorize the students to the exam page. The photo, name and date to be verified by the proctor prior to allowing the student in the exam page
 - Monitor the exam taker continuously and provide support till the end of the exam.
 - Remote proctors should also ensure proper conduct of examination and ensure that candidates use no unfair means during the exam, as per the details agreed upon by Vendor and Kurukshetra University, Kurukshetra.
 - Image capturing/streaming of the candidate for the entire duration of the exam at interval of 60 seconds.
- x. Details to be displayed on candidate console as part of Exam software during the exam:
 - Display of instructions to candidates on login and before start of examination. The candidate must be able to retrieve instructions at any time during the examination as well.
 - Start and closure of the examination at scheduled time (candidates must not be able to start their examination even if they login before the scheduled time).
 - Display of remaining time available

- Display of candidate details on the screen including a photograph during the examination.
- Viewing the complete question paper or a section in the case of sectional papers.
- xi. **Monitoring:** The server of agency/firm shall have the capability to start the examination for all candidates, monitor the status of each candidate (whether logged in, examination started, idle/active, disconnected, submitted, etc.). The server MUST maintain an audit trail of every operation of the students on the server.
- xii. **Master Control Facility:** The exam should be accessible for monitoring by Kurukshetra University, Kurukshetra, ably supported by technical personnel who are well versed with the Online Examination Software. At the end of examination in each session, the candidate response data and audit trail data of each candidate to be shared with Kurukshetra University, Kurukshetra. The vendor should provide the facility to monitor the pre-examination, during examination and post examination activities of all candidates taking exams simultaneously.

xiii. Post Examination Work:

- Download of the answer scripts/books (readable format like PDF) and handing over soft copy of answer books in PDF format paper-wise and class-wise to the concerned evaluation centres to be created by the University.
- For Remote proctored paper/pen exams, the scanned copies (readable format like pdf paper-wise and class-wise) must be shared on the day of the exam or next day. Audit logs for each and every candidate that covers the computer activity done by him/her should be shared with the Kurukshetra University, Kurukshetra.
- Individual candidate-wise, item-wise responses and audit trail will be captured and shared with Kurukshetra University, Kurukshetra. The agency/firm will maintain the data in a secure manner till instructed by Kurukshetra University, Kurukshetra before deleting the same.

3. <u>PREPARATION OF BIDS AND ON-LINE TENDER SUBMISSION</u>

Before submission of the tender, the agency/firm must verify the eligibility criteria and also ensure fulfilling all the terms and conditions. The bids without EMD or

with late receipt of EMD shall be summarily rejected. The agency/firms are required to submit soft copies of their bids electronically on <u>https://etenders.hry.nic.in</u> using valid Digital Signature Certificates.

- Downloading and submission of tender will be done by e-tendering process through the website <u>https://etenders.hry.nic.in</u>.
- (ii) Agency/firm should take into account any corrigendum published on the tender document before submitting their bids for which no separate advertisements shall be issued.
- (iii) Agency/firm should go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the tender.
- (iv) Agency/firm, in advance, should get the tender documents ready to be submitted as indicated in the tender document/schedule and they should be in PDF format.
- (v) The PDF file of the financial bid should be strictly password protected and the same password shall be obtained from the firms at the time of opening of financial bid.
- (vi) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- (vii) Upon the successful and timely submission of tender, the portal will give a successful bid submission message and a bid summary will be displayed with the bid No. and the date & time of submission of the bid with all other relevant details.

- (x) All the supporting documents to be submitted in each e-packet/cover should be in line with the requirements mentioned in this tender document.
- (xi) All the documents listed in Technical bid & Financial bid and supporting documents must be stamped and signed by the authorized signatory of the bidder.
- (xii) Kurukshetra University reserves the right to reject the bid, if, any of the above listed conditions are not met.

4. <u>ELIGIBILITY CRITERIA</u>

The bidder should process the requisite resources and capabilities in providing the services necessary to meet the requirement of Kurukshetra University Kurukshetra. The bid must be complete in all respect and should cover the entire cost of work as stipulated in the document. The bidder not meeting the eligibility criteria will not be considered for further evaluation. The PDF files of the technical and financial bids along with other supporting documents are to be submitted online at <u>https://etenders.hry.nic.in</u> under two separate E-packets/covers i.e. Pre-Qualification/Technical Bid (Technical Envelope) and Financial Bid (comprising of price bid proposal).

- (b) The financial bid shall contain only schedule of all the rates duly filled in. No stipulation, deviation, terms & conditions, presumptions etc. is permissible in financial bid. Kurukshetra University, Kurukshetra shall not take any cognizance of any such conditions and may at its discretion reject such bids.
- (c) Price offered by the bidder shall not appear anywhere in any manner in the technical bid.
- (d) The GST rate to be filled without fail. In case of receipt of bid without GST rate, it shall be construed that the rate quoted is inclusive of GST for further process.

- 5. <u>EVALUATION PROCEDURE AND SELECTION</u>: Bidders will be evaluated technically and will be qualified based on Information/documents provided and Technical presentation, if any. Only those Technical Bids that are found compliant/suitable after technical evaluation done by Kurukshetra University, Kurukshetra will be called for demo, if required and further considered for opening of financial bids.
- 6. <u>SECURITY DEPOSIT</u>: The successful bidder is required to furnish the Security Deposit in INR equivalent to 10% of the Contract / Order value (excluding taxes) in the form of Performance Bank Guarantee or Demand Draft drawn in favor of Registrar, Kurukshetra University Kurukshetra payable at Kurukshetra within 15 days of award of Contract/receipt of Order(s). The amount of Security Deposit will be forfeited to the extent of financial loss suffered by Kurukshetra University, Kurukshetra, if the successful bidder fails to execute the order and fulfill its terms and conditions. Relaxation to startup shall be given as per Haryana Govt. notification No. 2/2/2016-41B-II dated 03.01.2019 issued by Department of Industries & Commerce, Govt. of Haryana.
- PAYMENT PROCESS: The payment shall be made in Indian rupees and shall be paid only after the successful completion of the entire work without any delays or errors. Payment would be made to the successful bidder as per the charges quoted by the agency in the financial bid.
- 8. <u>PENALTIES</u>: Work should strictly be completed within the limit as per the work plan offered by the successful bidder and agreed upon by the Kurukshetra University, Kurukshetra. In case of any delay in completion beyond the stipulated time, liquidated damage @ 0.5% of the total contract value for delay per week shall be levied subject to maximum of 10% of the total contract value.

9. TERMS AND CONDITIONS: -

- (i) Earnest Money is liable to be forfeited and bid is liable to be rejected, if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of the tender.
- (ii) The Earnest Money of all unsuccessful bidders shall be returned as early as possible within the Bid Validity period but not before 120 days from the date

of Work Order. No interest will be payable by Kurukshetra University, Kurukshetra on the Earnest Money Deposit. The Earnest Money of successful bidder shall be returned to the successful bidder after submission of Performance Bank Guarantee (BG) or DD equivalent to 10% of order value towards "Security Deposit".

- (iii) Govt. Levies like GST, etc. shall be paid at actual rates applicable on the date of submission of Bid. Rates should be quoted accordingly giving the basic price, GST etc.
- (iv) Offer Validity: Offers should be valid for minimum One Twenty(120) Days from the date of opening the Technical Bid. A bid, valid for a shorter period, is liable to be rejected. Kurukshetra University, Kurukshetra may ask the bidders to extend the period of validity, if required.
