Subject: Award of University Research Scholarship for the year 2020-21.

Reference your application dated 02-02-2021 on the subject cited above.

It is to inform you that the Registrar, on the recommendations of the University Research Scholarship Selection Committee, has been pleased to award you the University Research Scholarship leading to Ph.D. Degree in the subject of **Statistics & Operational Research** on the following conditions given below:-


During the tenure of Research Scholarship you will be required to do whole time Research in the field chosen for the purpose. The terms and conditions governing the award of the above scholarship are as under:-

1. The above scholarship is tenable for a period of two years from the date of joining the scholarship in the department concerned.
2. During the period of Scholarship, you will be paid research Scholarship @₹7000/- p.m. for the first year and second year subject to your satisfactory progress of work.
3. You will be required to qualify Course Work if not exempted for the same.
4. You will be required to submit a certificate of progress and satisfactory work done through the Supervisor and Chairperson of the Department concerned at the end of each term.
5. The Scholarship may be extended on yearly extension basis ordinarily for a period of one year but in no case beyond a period of two years by the Vice-Chancellor on the recommendations of a Committee consisting of Supervisor and Chairperson of the Department.
6. During the period of Research Scholarship you will not join any other course of study or appear at any other Examination conducted by any University or Public body unless allowed by the Vice-Chancellor to do so.

7. In the event of your discontinuing or giving up the work before the expiry of one year or before the expiry of the extended period if extension is allowed for no valid reasons, you will be required to refund the whole amount of scholarship drawn by you during the tenure.
8. You will be entitled for leave as per provisions of the Ordinance.
9. In case of concealment of any fact you will not only be debarred from getting the Research Scholarship but also be bound to refund to the University, the whole amount of Scholarship drawn by you during the tenure of Research Scholarship.
10. You are, required to execute a bond with the University on non-judicial stamp paper duly attested by the 1st class Magistrate. The prescribed format of the Bond appears at page 252-253 of K.U. Cal. Volume-I 2009. The bond so executed should be duly checked and verified by the Supervisor and countersigned by the Chairperson of the Department concerned. The Surety to be given in the Bond should be from any one of the following:-
 - a) A permanent employee of the University.
 - b) A permanent employee of the State Government.
 - c) A permanent employee of autonomous statutory bodies situated in Haryana.
 - d) Natural parents/legal guardian having property/employment.
11. You are required to complete the full tenure of Research Scholarship and in no case, you can resign and forgo the Scholarship unless permitted by University to do so.
12. The Scholarship may be terminated at any time without assigning any reasons and the decision of the University in this regard shall be final.
13. The other terms and conditions not specified in the above letter, the instructions issued by the University and the amendments and additions made by the University in the rules from time to time will be binding on you.
14. If you accept the offer on the terms and conditions as stated above you may join the **Department of Statistics & Operational Research** upto **15-03-2021**, failing which the offer will be treated as cancelled ab-initio and the Scholarship will be offered to the next eligible candidate. The format of joining report is enclosed for the purpose.



1. ✓ The Chairperson, **Department of Statistics & Operational Research**, KUK with reference to their office letter No.Stat./21/74 dated 09-02-2021 received in this office with the recommendations of the University Research Scholarship for the year 2020-21. He is requested kindly to adhere to the following:-

- a. The Joining Report and the Bond (duly attested by the 1st class Magistrate) so executed by the Scholar concerned, duly completed in all respect, must reach the undersigned **immediately** after the joining of the scholar concerned.
- b. Report relating to the satisfactory completion of Course Work and recommendations of P.G. Board of Studies for Ph.D. registration must reach the undersigned so that confirmation case of the scholar concerned is processed well in time and the payment of Research scholarship may not be stopped.
- c. It may also be ensured that the scholar concerned attends the Department and does his/her research work regularly and mark his/her attendance daily in the attendance register maintained for the purpose in the Department. In no case the scholar concerned is allowed to leave the Department without prior permission.
- d. While sending request for extension for third and fourth year, guidelines issued vide notification Endst.No.Sch.S-I/90/URS/2149-90 dated 18-04-1990 must be kept in view and the case(s) be forwarded/recommended accordingly.
- e. In case the scholar remains absent from the Department without prior permission of the Chairperson or discontinues the tenure of one year or before the expiry of the extended period, if extension is allowed a report including the period of absence with observations thereon must be sent to the undersigned within three days, failing which action will be taken against the person responsible for this lapse.
- f. Report on the satisfactory progress on the work of the scholars shall be submitted to the Board by the Chairperson of Department concerned once every quarter. The continuance of the Scholarship would depend on the satisfactory progress of work of the scholars.
