NOTIFICATION

Applications are invited for the award of Dr. Radha Krishnan Foundation Fund Scholarship from Under-graduate and Post-graduate students studying in University Teaching Departments/Institutes/Institute of Integrated & Honors Studies for the session 2022-23 as per details given below:-

1. General Scholarships

A. For Under Graduate Classes

i. Merit-Cum-Means Basis Scholarship:

100 number of Scholarships shall be awarded on Merit-Cum-Means basis @ Rs.750/- p.m. to the students of Under-graduate classes, studying in Part-I/First Year classes on the basis of their lower examinations, i.e. 10+2 passed in April/May, every year securing at least 60% marks.

ii. Below Poverty Line (BPL) Scholarship:

40 number of Scholarships shall be awarded on below poverty line basis @ Rs.750/- p.m. to BPL card holder students of Under-graduate classes studying in Part-I/First Year classes, on the basis of their lower examinations, i.e., 10+2 passed in April/May every year. The conditions of % of marks will not apply to BPL students.

B. For Post-Graduate Classes

i. Merit-Cum-Means Basis Scholarship:

200 number of Scholarships shall be awarded on Merit-Cum-Means basis @ Rs.1000/- p.m. to the students of Post-Graduate Classes studying in First Year classes of University Teaching Departments/Institutes on the basis of their lower examinations, i.e., B.A./B.Sc./ B.Com./B.Sc. Home Sci./B.C.A./B.Lib. Sci./LL.B./B.Tech./B.Pharmacy (Final) etc. passed in April/May every year securing at least 60%.

ii. Below Poverty Line (BPL) Scholarship:

40 number of Scholarships shall be awarded on below poverty line basis @ Rs.1000/- p.m. to BPL card holder students of Post-graduate classes studying in Part-I/First Year classes, on the basis of their lower examinations, i.e., B.A./B.Sc./B.Com./B.Sc. Home Sci./B.C.A./B.Lib. Sci./LL.B./B.Tech./B.Pharmacy etc. passed in April/May every year. The conditions of % of marks will not apply to BPL students.

2. Special Scholarships

i. Deceased University Employee Scholarship:

The Scholarship to one child of each deceased employee of the University will be awarded @ Rs.750/- p.m. for UG and Rs.1000/- p.m. for PG students studying in the University Teaching Departments/Institutes.

ii. Disability Scholarship:

All the Disabled Students of Under-graduate/Post-graduate studying in University Teaching Departments/Institutes with disability above 50%, will be awarded the Scholarship @ Rs.750/- p.m. for UG and Rs.1000/- p.m. for PG students, respectively.

iii. Bravery Award/President Medal Scholarship:

Scholarships for Under-graduate and Post-graduate students will be awarded to those students who have won National Level Bravery Award/President Medal @ Rs.750/- p.m. for UG and Rs.1000/- p.m. for PG. The conditions of % of marks will not apply to National Level Bravery Award/President Medal Students.

3. **Duration of Scholarships and conditions for Renewal of Scholarship**

- i. Initial duration of the Scholarship is of One Year, i.e. 12 months..
- ii. All Dr. R.K.F.F. Scholarships are tenable for the entire duration (in the case of 5 Yr. Integrated Courses, First 3 Yr.) of the course/rest of the course but are renewable on year to year basis. The renewal of scholarships are subject to **condition that the awardees should have passed the lower examinations without re-appear securing at least 60% marks in 1st attempt.** There are no conditions of % of marks for the BPL Card Holder/Disable, President Award and National Level Bravery Award students. All the awardees of these scholarships will have to submit a certificate of good conduct from the Chairpersons/Directors of the University Teaching Departments/Institutes.
- iii. Complete Application Forms in all respect on the prescribed proforma should reach to Superintendent Scholarship, Kurukshetra University, Kurukshetra through the Chairperson/Director of the University Teaching Department/Institute/Principal **upto 30th November, 2022** positively. **Incomplete Application Forms and Applications received after 30th November, 2022 will not be considered/entertained and such Application Forms shall stand rejected automatically.**
- iv. The Students availing Scholarship can be continue in subsequent years of the respective course if the student has clearly passed with atleast 60% marks in the last year.

4. **Other Conditions:**

- i. If a student is receiving any other Scholarship/Stipend/Financial Aid from any other source, he/she is not eligible to receive this scholarship. The Chairpersons/Directors of the University Teaching Departments/Institutes shall take **an undertaking from the student** to the effect that he/she has not received/receiving any other Scholarship/Stipend/Financial Aid etc.
- ii. The Applicant must attach with the Application Form an attested copy of the **DMCs of the lower examinations** passed in April/May of previous year.
- iii. **The applicant with Annual Income upto Rs.6 Lac would be eligible for award of Dr. R.K.F.F. Scholarship.** The applicant must give the total annual income of the family from all sources in the Application Form. The total annual income should include Income/Gross salary of both the parents/guardians. The applicant should submit an Income Certificate from the Employer in case of Employee, and in other cases in the form of an Affidavit duly attested by the 1st Class Magistrate with the Application Form. The Certificate/Affidavit should not be older than on year.
- iv. **The Chairpersons/Director shall forward maximum 10 applications** per 100 students enrolled in the respective department/Institute. Maximum 5 Scholarships out of 10 applications can be awarded to the Post-graduate students (on the Merit-cum-Means Basis) of each University Teaching Department/Institute.
