The selected candidates are required to visit *Institute of Pharmaceutical Sciences*, Kurukshetra University, Kurukshetra in person along with all original documents for verification of same on 26<sup>th</sup> -28<sup>th</sup> July 2023 (9:00 am to 5:00 pm). **The candidates, whose final year/semester examination is not declared yet, are required to submit an undertaking that he/she will submit the proof of passing final year/semester examination by the stipulated date mentioned in the HBI-23 failing which his/her provisional admission will be cancelled ab-initio and no fee will be refunded.**

If a candidate is admitted on the basis of the information submitted by him/her, which is found to be incorrect or false or incomplete or modified at a later stage, or any misinterpretation/concealment of facts/errors/omissions/alterations is found, then his/her admission will be cancelled and all fees and other dues paid by him/her shall be forfeited.

After successfully verification of documents, the candidate can deposit the fee till 28<sup>th</sup> July 2023 (upto 23:59 hrs.). **The candidate will deposit the fee in online mode only through the University Admission Portal using their own login ID and password.
