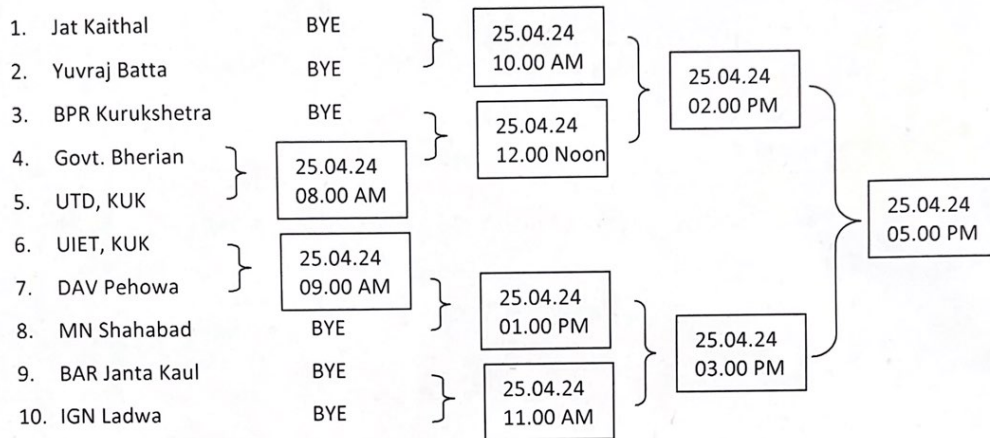

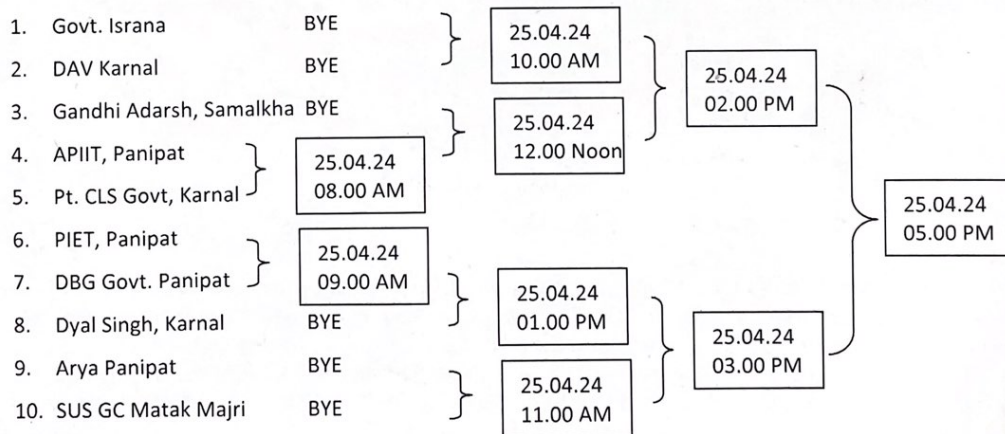

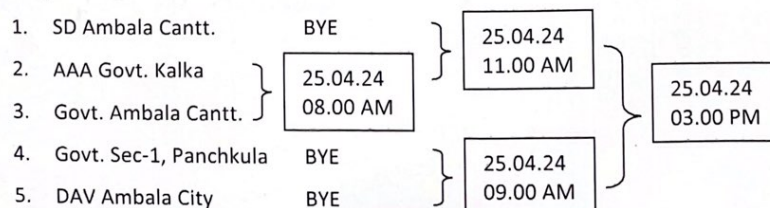
#### Zone A-Kurukshetra, Kaithal at Jat College, Kaithal



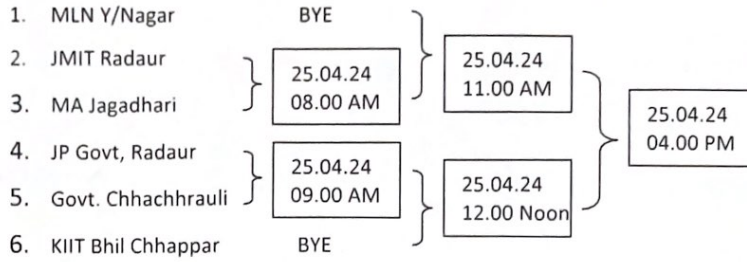
#### Zone B-Karnal, Panipat at Arya PG College, Panipat



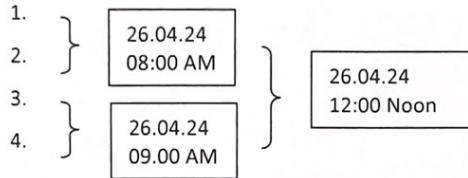
