Subject:- Regarding introduction/ offer Honours at UG level under Scheme B and C in the  
affiliated colleges under NEP 2020.

Sir/Madam,

It is to inform you that on the recommendations of the Committee regarding  
introduction/ offer Honours at UG level under Scheme B and C in the affiliated colleges under NEP  
2020 has been considered by the Hon'ble Vice-Chancellor:-

- (1) The request of the Colleges for seeking permission to offer the UG programme (Hons.) in the concerned subjects under the Scheme B was considered by the Committee and after deliberating over the issues in details and committee recommended that the permission to offer UG. Programme (Hons) under the Scheme B may be allowed subject to the following conditions:-
  - (i) One time application fee of Rs. 10,000/-+GST 18% per subject and submission of annual extension fee of Rs. 10000/-+GST 18% per subject as applicable for Honours programme according to rules of the University.
  - (ii) Submission of NOC issued by the DGHE Haryana in case the when Hons/ programme is to be run under SFS and submission the approval from the DGHE in case the programme is offered as a budgeted programme/course.
  - (iii) The Committee recommended that the proposal to offer Single Major subject under Scheme B may be accepted subject to conditions mentioned under Sr. No. 2 sub point No. (i & ii).
  - (iv) The Committee recommended that if the colleges starts UG programmes (Hons) under Scheme B and C both then they should apply for scheme B and C separately.
  - (v) The Committee recommended for the proposal to introduce/start the UG programmes (Hons.) subjects under Scheme C on SFS basis w.e.f. the session 2024-2025, the conditions of the same for introduction of new subjects/courses on submission of application & provisional affiliation fee on the recommendations of the Inspection Committee on receipt of approval/NOC from the regulatory bodies for the purpose.

You are requested to follow the above guidelines/instructions for the purpose.
