## **NOTIFICATION**

1. Applications are invited for re-employment in the University for University Teachers. Detailed guidelines containing application proforma are available on University website.
2. Applications are invited from eligible teachers fulfilling all requisite qualifications and minimum score required under the API scoring system, who wish to be considered for promotion under Career Advancement Scheme in terms of the State Govt. Notification No. KW-7/18- 2009 C-IV (3) dated 21.07.2011 and No. 7/79-2017 C-IV (3) dated 11.11.2022 adopted by the University vide Executive Council Res. No. 41 dated 09.08.2011, E.C Res. No. 40 dated 24.07.2020, Res. No. 16 dated 30.12.2022, Res. No. 35 dated 22.08.2023 and Res. No.24 dated 04.03.2024, for the following positions:

i)	Senior Professor (Academic Level-14 to Academic Level-15)	From Professors (AL-14) working against sanctioned budgeted posts only in University Teaching Departments/Institutes.
ii)	Professor (Academic Level-13A to Academic Level-14)	From Associate Professors (AL-13A) working against sanctioned budgeted posts only in University Teaching Departments/Institutes.
iii)	Associate Professor (Academic Level-12 to Academic Level-13A)	From Assistant Professors (AL-12) working against sanctioned budgeted posts as well as those working under Self-Financing Scheme.
iv)	Assistant Professor (Academic Level-11 to Academic Level-12)	From Assistant Professors (AL-11) working against sanctioned budgeted posts as well as those working under Self Financing Scheme.
v)	Assistant Professor (Academic Level-10 to Academic Level-11)	From Assistant Professors (AL-10) working against sanctioned budgeted posts as well as those working under Self-Financing Scheme.

The following instructions for forwarding of application forms may be followed:

1	In case of promotion under CAS to the post of Senior Professor	<ol style="list-style-type: none"><li>i. Applications of Senior Professor will be forwarded by the concerned Chairperson/ Director of the Department/ Institute.</li><li>ii. In case the applicant is a Chairperson/Director, then the application will be forwarded by the Dean of concerned Faculty.</li><li>iii. In case the applicant is a Chairperson/Director as well as Dean of the Faculty, then the application will be forwarded directly by the concerned teacher as a Dean, Faculty to the Establishment Branch.</li></ol>
2)	In case of promotion under CAS upto the posts of Professor (Academic Level-14)	<ol style="list-style-type: none"><li>i. If the applicant is a Chairperson/Director, then the contents of the Table-1 of the application form will be verified by the Senior Most Professor of the Department/Institute.</li><li>ii. When there is no Professor available in the Department/Institute and Chairman/Director is an</li></ol>

		<p>applicant, then a committee of three Professors, constituted by the Dean of the concerned Faculty, will verify the contents of the Table-1 of the application form.</p> <p>However, the application form in both the cases will be forwarded by the concerned Dean Faculty.</p>
3)	In case of promotion upto the designation of Deputy Librarian (Academic Level-14) when there is no Librarian present in the University	<p>i. A three-member committee consisting of Dean, Faculty of Arts &amp; Languages, Senior most Professor and next Senior Professor of the Library and Information Science Department will verify the contents of the Table-1 of the application form.</p> <p>ii. In case, when there is only one Professor in the Department of Library and Information Science, then Dean of Faculty concerned may co-opt one Professor from other department in the above mentioned committee.</p> <p>iii. In case, when there is no Professor in the department of Library and Information Science, then the Dean of concerned Faculty may co-opt two senior Professors from other departments in the above-mentioned Committee. However, the application form in the above cases will be forwarded by the Dean of concerned Faculty.</p>

- Note:** (1) The applicants whose date of eligibility for promotion under CAS falls before 01.07.2023 are to be governed under old guidelines as per State Govt. instructions dated 21.07.2011.
- (2) The applicants whose date of eligibility for promotion under CAS falls on or after 01.07.2023 are to be governed as per State Govt. instructions dated 11.11.2022.

Applications complete in all respects alongwith PBAS form duly verified by the respective Chairperson/Director/Principal of the Department/Institute/IIHS/ITTR may be sent to the Deputy Registrar, Establishment Branch (T), Kurukshetra University, Kurukshetra and for Re-employment should reach in the O/o Vice-Chancellor. The requisite application Form/Proforma are available on the University website i.e. <https://kuk.ac.in/university-notices>. The last date for submission of application forms is **30.08.2024**.
