- 1) For newly admitted students of B.Tech. 1st Sem/B.Tech. 3rd Sem (Lateral entry), that might get late admission due to extended counselling schedule (if any) for session 2024-25, special attention is to be paid by the concerned institute to make good the loss/deficit of teaching by making provisions of additional periods/slots in the time table within the stipulated working hours and by arranging extra classes (on weekdays/weekends) on needs basis, to complete the syllabus in time. The Sessional exams may be scheduled by the concerned institute, accordingly.
- 2) If the number of teaching/working days for any class falls less than 180 days (in general i.e. approx. 90 days in each semester) due to some unforeseen reasons, it would be the responsibility of each Institute/College to compensate the loss by arranging extra classes, on need basis.
- 3) The students must adhere to the fulfillment of minimum attendance conditions regarding attending their classes.
