

Minutes of the meeting of the committee constituted by the Hon'ble Vice-Chancellor held on 13.09.2022 at 11:30 a.m in the Committee room, Administrative Block to review and strengthen the measure to curb the menace of ragging in the University and its affiliated Colleges for the session 2022-23: -

The Dean Students' Welfare apprised the Committee that Ragging is totally prohibited in the University Teaching Depts./Institutes & its affiliated colleges/Institutes of the K.U. Kurukshetra and anyone found guilty of ragging and/or abetting ragging, whether actively or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with the UGC Regulations on curbing and Menace of Ragging in Higher Educational Institutions, 2009 and "The Haryana Prohibitions of Ragging in Educational Institution Ordinance, 2012" as well as under the provisions of any penal law for the time being in force. UGC and State Regulations/Ordinance, 2012 alongwith measures to be taken for curbing the menace of ragging were already circulated to all the UTDs/institutes for strict implementation. Instructions in this regard are also issued to all the affiliated Colleges/Institutes by the Dean of Colleges.

The Committee reviewed the measures taken during the last year and noted that:

- i. For the session 2022-23 directions regarding curbing the menace of ragging, anti-ragging committee, anti-ragging squads (zone-wise) constituted by the University, toll free anti-ragging helpline numbers and e-mail helpline, self-declaration by the student and his/her parents to the effect that the student will not indulge in ragging, and if found so, will be liable for punishment as per UGC and State regulations, have been included in the Prospectuses of various courses and also in the Hostel Rules & Regulations.

- ii. Posters as per Clause 6.1 (a) that "the ragging is totally prohibited in the Institution and anyone found guilty of ragging and/or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with UGC Regulations ([www.ugc.ac.in](http://www.ugc.ac.in)) as well as under the provisions of any penal law for the time being in force" will be got printed and will be pasted by the office of the Dean Students' Welfare at all important places in the University Campus.

The Committee further made the following recommendations for implementation: -

1. DSW will arrange to display Flex Boards carrying anti-ragging message along with important Telephone Nos. at various prominent places on the University Campus.
2. DPR will take action for wide publicity of the measures which the University takes to curb the menace of ragging from time to time (ref 6.4 (e))
3. Dean of Colleges will make the recommendations to colleges/institutes with reference to Clause 6.1(c), 6.1(f), 6.4(l), 6.4(n), 9.2 of UGC Regulations. ([www.ugc.ac.in](http://www.ugc.ac.in).)
4. All Chairpersons, Directors and Principals on the University Campus will take self declaration from every enrolled students and their parents on the prescribed proforma given in the Prospectus. However, this is not required to be obtained from the promotee students as they have already given it at the time of their admission during the last year.
5. It will be mandatory for a Chairperson, Director, Principal, to include the paragraph as to whether the student has been punished for committing or abetting an act of ragging as also displayed persistent violent or aggressive behaviour or any inclination to harm others, during his/her course of study in the institution (with ref. to Clause 6.4(m)) in the character certificate to be issued from the Department/Institution/College last attended. ([www.ugc.ac.in](http://www.ugc.ac.in).)
6. An induction programme shall be arranged as and when possible in which the Vice-Chancellor alongwith Registrar and other senior functionaries/officers of the University will address to freshers students in the University Auditorium. Dean Students' Welfare will arrange to download 'Documentary on Anti Ragging' available on UGC website and display it during this programme and ensure its circulation to the University Teaching Departments/Institutes.
7. All the Chairpersons/Directors/Principals/Wardens of UTDs/Institutes/Hostels on the Campus will arrange to show the 'Documentary on Anti Ragging' as stated above at Sr. No. 6 to the Junior & Senior Students. Dean of Colleges will issue instructions to all the affiliated Colleges/Institutes in this regard.
8. Every institution shall engage or seek the assistance of professional counsellors before the commencement of the academic session, to be available when required by the institution, for the purposes of offering counselling to freshers and to other students after the commencement of the academic year.

As per clause 6.1 (o) of the UGC Regulations, following are the panel of the Counselors to whom freshers and other students can approach for counselling purposes during the academic session 2022-23.

Remuneration to outside consultant at S. No. 6&7 above will be paid at par with consultation rate for the slip issued from the University Health Centre.

9. A leaflet incorporating Telephone Nos. of Anti Ragging Help Line, Anti Ragging Committee and Anti Ragging Squads will be got printed by DSW after getting the same from the office of the Proctor and will be circulated to all Chairpersons, Directors and Principals of the Departments/Institutes and they will provide these printed leaflet to every fresh student admitted.

10. As a regular practice, UGC Toll free Anti-Ragging Help line Number 1800-180-5522 and E-mail - help line @ [antiragging.net](mailto:antiragging.net), and the Telephone numbers of University Anti-Ragging Committee, Anti-Ragging Squads, Monitoring Cell, Nodal Officers and Counsellors are displayed on the University Web-site. In addition, official E-mail address of the Vice-Chancellor and Registrar are also displayed on the University Web-site. (Proctor/Director, IT Cell)
11. **All the Chairpersons, Directors and Principals of the Departments/Institutes** will arrange Orientation programme/Induction sessions on Anti-Ragging awareness at Department/Institute/College level, within one month of admission {Ref. Clause 6.2(b), (e)} and will include the list of such programmes in the academic calendar ([www.ugc.ac.in](http://www.ugc.ac.in)) for record.
12. **Chief Wardens (Boys & Girls Hostels)** will meet the requirements under Clause 6.1(b), 6.2(e, j, k), 6.4(b, i) or other relevant clauses of the UGC regulations. ([www.ugc.ac.in](http://www.ugc.ac.in)).
13. **All the Chairpersons, Directors and Principals of the Departments/Institutes** will depute teachers one each for a group of 15 to 20 fresh students for interacting with them. These interactions may be held in the tutorial periods or in other classes in the first month at the start of the session {Ref. 6.2(f, h, i)}. ([www.ugc.ac.in](http://www.ugc.ac.in)).  
Every Chairperson should ensure that mentor is assigned for the freshers students on priority and the mentor-mentee meetings are held within a week after the start of the classes and be held thereafter frequently after every 15 days initially.
14. **All the Chairpersons, Directors and Principals** will meet requirements under clause 6.1(d, e, f, g, h, n), 6.2(a, b, c, f, g, h, n, & o) & 6.4 (i) ([www.ugc.ac.in](http://www.ugc.ac.in)).
15. **Dean of Colleges** is Nodal Officer for the affiliated Colleges/Institutes. He will take all measures to ensure that steps taken by the University from time to time are also implemented at the level of Affiliated Colleges/Institutes. The Principals/Directors of the Colleges/Institutions affiliated to Kurukshetra University shall submit a weekly report on the status of compliance with anti-ragging measures under these regulations and monthly report on such status thereafter to the Nodal Officer of Kurukshetra University. **All Chairpersons, Directors and Principals of the Departments/Institutes** will submit such reports to the office of Proctor, KUK who is Nodal Officer for Anti-Ragging measures on the University Campus.
16. **Anti Ragging Squads** will keep vigilance in Boys Hostels, Girls Hostels and other vulnerable areas of the University. Anti Ragging Squads, constituted for Hostels will also raid the Hostel in the night. On finding any case of ragging, the squad will report the matter to the Anti Ragging Committee.
17. **Anti Ragging Committee** will periodically review the situation and the information supplied by the Anti Ragging Squads and recommend actions as per UGC regulations. Minutes of the meetings of the Anti Ragging Committee will be placed before the Monitoring Cell of the University. Monitoring Cell will consists the following members:-
  - (i) Registrar
  - (ii) Dean, Academic Affairs
  - (iii) Proctor
  - (iv) Dean of Colleges
  - (v) Dean Students' Welfare
18. A close watch should be kept on all outside anti-social elements and it should be ensured that they may not enter the University Campus. For this purpose intensive patrolling on the University Campus should be carried out. The students, whose entry into University Campus has been banned, should not be allowed to enter the University Campus/Hostels. (CSO)

10. The CSO will ensure that the Gates on the Canal Road should be locked up-to 31<sup>st</sup> December, 2022 and no entry should be allowed from these gates except from 08.00 a.m. to 10.00 a.m. and from 04.00 p.m. to 06.00 p.m. only for the convenience of employees. No students will be allowed to use this road upto the month of 31<sup>st</sup> December, 2022.

20. The CSO will contact the concerned Police Officer and make necessary arrangements for patrolling on the campus till December 2022. It was decided that during evening hours a few police personnel security personnel may be deployed on the road leading to the Girls hostels so that the male students be not allowed to stand near the Girls hostels after the visiting hours. The Warden(s) of the Girls hostels should take round on the main gates of the hostels.

**Special Vigil be kept over on the students of 5-year Integrated/other professional courses.**

21. As per clause 6.2 (p) of UGC Regulations, the CSO (Security) shall also instruct mobile patrolling party to bring to the notice of the University authorities any incident of ragging immediately. No incident of ragging will be hushed up. Even small incident of ragging will have to be reported. The patrolling party will not only keep a close watch on the activities of the students on the University Campus, but also visit Jyotisar, Shekh Chilli Tomb, Brahmrover, Jindal Park and other nearby picnic-spots and ensure that the students are not indulging in ragging even outside the University Campus. The CSO (Security) will also put some security-men on patrolling duty on the Rose Garden, University Canteens, Open Air Theater etc. who will immediately bring into the notice of Proctor/DSW/Chief Wardens/Deputy Proctors/Registrar/Chairperson/ Director of the concerned Department/Institute if any incident of Ragging comes to their notice. DSW will arrange the meeting of the Canteen Contractors/owners and they should be asked to bring the incident of ragging, if any, to the notice of the University authorities.

22. In every Department/Institute/College a Committee of a few teachers should be formed which may watch the activities of the students especially during lunch hours/recess and also when they come to the departments/institutes/colleges and go back to their Hostels. If any incident of ragging comes to the notice of any member of above Committee or any other member of the teaching or Non-teaching staff, it should immediately be brought to the notice of the Proctor/DSW/Chief Wardens/Deputy Chief Wardens/Registrar/ Deputy Proctors/ CSO (Security). The Non-teaching staff in every Departments/Institutes/Hostels should also remain alert towards incident of ragging. They should report promptly any case which comes to their notice.

The Chairpersons/Directors/Principals shall constitute a Committee under the teachers by involving Senior Students and Freshers to report any act of ragging. Similar committee shall also be constituted by the Wardens of Hostels (Boys & Girls) to prevent any act of ragging in the Hostels.

23. The Chairpersons of University Teaching Departments/Directors/Principals of Institutes shall convene meetings of teachers & non-teaching staff of their Departments/Institutes and bring to their notice all anti-ragging measures being taken by the University. The teachers of their Departments/Institutes shall further inform the students about the consequences of ragging and ensure that no incident of ragging takes place in their Department/Institute and other vulnerable places. As a regular practice, the teachers will remain present in the Department/Institute from 9.00 a.m. to 5.00 p.m. for two months from the start of classes and the Chairpersons/Directors/Principals will ensure compliance.

24. The Chairpersons/Directors/Principals shall make all efforts that no class should be left unattended by the teachers and will send weekly attendance report of students on

- the prescribed proforma (to be devised by the Chairperson/Director/ Principal concerned) for information of the Vice-Chancellor.
25. It was also decided that the students shall not be allowed to hold any party outside the campus. **Proctor** shall write a letter to the **Deputy Commissioner and Superintendent of Police, Kurukshetra** requesting that the owners of Hotels in the city should not allow the students to hold any parties in their Hotels to avoid any untoward incident. In case they suspect any such activity at their premises, they should inform immediately the University authorities or Distt. Administration for further necessary action. A letter in this regard be also written to all the Hotel owners in the city (**Proctor**).
  26. **The Chief Wardens** shall convene the meeting of the **Deputy Chief Wardens/ Wardens** of all the Hostels and bring to their notice the necessity of their active involvement in "No Ragging" programme and put them on 24 hours visit to ensure that no incident of ragging takes place on the Campus (**CW**).
  27. To avoid any incident of ragging in the Hostels during night hours, it was decided that anti ragging Squads will carry out night patrolling. They would be provided a vehicle by the **General Branch** for this purpose. The **Hostel Supervisor** shall remain present in the hostel from 9.00 p.m. to 12.00 midnight to check the incidents of ragging upto 31<sup>st</sup> December, 2022. All the wardens shall also check their hostels from 9.00 p.m. to 12.00 midnight (**A.R. General/All Wardens/Proctor**).
  28. During the first two months of starting of the classes, no guest of the students should be allowed to stay in the Hostels. No student should be allowed to enter in the University Hostel without Hostel identity card. (**All Wardens**)
  29. If any fresher student is found in the room of the senior student or any senior student is found in the room of the fresher student during night hours in the Hostel, the senior student will be dealt with penal provisions of UGC regulations. (**All Wardens**).
  30. **The Security-personnel** posted at the Hostels should also remain alert and if any incident of ragging in the hostels during night hours comes to their notice, they should immediately inform about the same to the concerned **Warden/Chief Warden/Deputy Chief Wardens**. They should also keep with them the telephone numbers of all the functionaries. (**CSO**)
  31. It was also decided that regular mess of Girls Hostels should be started from the date of start of classes so that the girl students need not to go out from the hostels. **Wardens** will ensure the proper security of the students. (**Chief Wardens (Girls)**)
  32. It was also decided that Ist year students should be kept separately from senior students as far as possible in University Hostels. (**Chief Wardens (Girls & Boys)**)
  33. **The Chief Wardens and the CSO** will have periodical meetings with their staff to review the position from time to time and to put the information in the meetings of **Anti-Ragging Committee (Chief Wardens & CSO)**.
  34. It was also decided that anti-ragging measures taken by the University should be brought to the notice of **Principals/Directors of Affiliated Colleges/Institutes** to take similar actions in respect of their **Colleges/Institutes**. **The Dean of Colleges** will issue instructions to the **Principals/Directors of affiliated Colleges/Institutes** especially to **Technical Institutions** to ensure that no untoward incident occurs in their **College/Institution**. The Institution failing to curb ragging or fail to follow the UGC regulations & "The Haryana Prohibitions of Ragging in Educational Institution Ordinance, 2012" in letter and spirit will be dealt severely and stern action, to the extent of disaffiliation of the concerned institution, will be taken. (**Dean of Colleges**)

35. The Chairpersons/Directors/Principals of Departments/Institutes will ensure the following: -

- (i) To issue the temporary ID Cards to fresh admitted students. The data of the students who have been admitted through IUMS will be provided by the Coordinator IUMS to the General Branch and for other students, who have not been admitted through IUMS, data will be provided by the Chairpersons/Directors/Principals of the UTDs/Institutes/Colleges to the General Branch so that their permanent PVC Id Cards can be made.
  - (ii) To collect ID Card Fee as notified by the University along with Students Information form.
  - (iii) To collect self-declaration with regard to not involving in ragging activities signed by the students and his/her Parents.
  - (iv) To inform all the Students, Freshers as well as seniors, to keep their ID Cards always with them. It shall be obligatory on the part of Chairpersons/Directors/ Principals to issue temporary ID Cards if the permanent PVC ID Card has not been issued to a student. Manager, Printing Press, K.U.K will make arrangements for printing of Temporary ID Cards on card paper to make those available for departments/IHS/ITTR/UIET. Hostel residents will also keep their postal ID card with them.
36. Nodal Officer, Proctor office may be authorized to facilitate safety & security apps without affecting the privacy of individual students with regard to create the avenues to spread the idea of ragging free campus (Ref. UGC letter No. 1-15/2009 (ARC) pt.III dated 28 may 2018).
37. As per UGC letter No. F.3-2/2021 (ARC) dated 27.10.2021/AICTE letter No. 1-104/AICTE/PGRC/Anti-ragging/2021 dated 22.11.2021, it is compulsory for each student and his/her parent/guardian to submit an online undertaking each academic year at either of the two designated websites, namely, [www.antiragging.in](http://www.antiragging.in) and [www.amanmovement.org](http://www.amanmovement.org) . Therefore, all the Chairpersons/Directors/Principals may ensure about implementation of UGC letter dated 27.10.2021 (copy enclosed)

A meeting of the Proctorial Committee held on 02.09.2022 at 03:00 PM in the office the Proctor. The following issues come up for discussion:

1. The request dated 27.06.2022 from Mr. Vineet, roll no. 211681, student of BCA-I<sup>st</sup> year of IHIS, KUK regarding exemption of fine of Rs. 5000/- and allotment of hostel accommodation. The Proctorial committee perused the request of the applicant, relevant record and was apprised that in the recent past, the applicant was imposed a fine of Rs. 5000/- by the Proctorial committee and expelled from the hostel accommodation vide notification no. ACM-I/St.6/22/7632-42 dated 23.06.2022 due to accommodating an outsider in hostel and involvement of that outsider in a quarrel which took place in hostel premises between applicant and accused students.

Another request dated 28.06.2022 from all the accused students namely 1. Mr. Himanshu, Roll No. 202462, BA (Voc.)-II, 2. Mr. Sagar, Roll No. 191024, B.Sc. (EEM) Final, 3. Mr. Keshav Sharma, Roll No. 190932, B.Sc. (Electronics) Final of IHIS, KUK and 4. Mr. Nitesh Grover, Roll No. 252002057, B.Tech. CSE: 4<sup>th</sup> sem. of UIET, who abused and assaulted Mr. Vineet in hostel premises under influence of liquor without any reason. When he resisted, they hit him with belt and warned for consequences. Other two 1. Mr. Pankaj, Roll No. 191035, B.Sc.(EEM) Final and 2. Mr. Vijay Kumar, Roll No. 190928, B.Sc. (Electronics) Final of IHIS, KUK were continuously accommodating the accused students in their hostel room no. C-81. All of them also requested for exemption of fine of Rs. 15000/- imposed upon each vide notification dated 23.06.2022.

The Proctorial committee deliberated in the matter in details and is of the considered view that to maintain the discipline in the University as well as hostel premises, the request for exemption the fine and expulsion from hostel is not considered. Hence, the Committee unanimously decides as under:

**THAT THERE IS NO BASE TO GIVE ANY RELIEF TO ANYONE AND THE DECISION ALREADY TAKEN IN THE MATTER AND NOTIFIED VIDE NOTIFICATION NO. ACM-I/St.6/22/7632-42 DATED 23.06.2022 SHALL CONTINUE TO BE IN OPERATION AND THE SAME MUST BE ADHERED TO IN TRUE SPIRIT.**






2. Mr. Vivek, outsider (as reported by the security he tells himself student of the University but never ever show his ID card even on demand), 3. Mr. Navjot Singh S/o Sh. Jasbir Singh, BTM-I of IHIS, 4. Mr. Amit Kumar S/o Sh. Satpal and 5. Mr. Gurpreet Singh S/o Sh. Satnam Singh both student of MA (Public Admn.)-II, Dept. of Public Administration, KUK making nuisance in the University Campus by rashly driving their four wheelers (Cars) every time most likely during odd hours. They frequently visit without any reason on their vehicles inside and outside the campus and try to threaten the security staff during performing their duties.

In view of the above facts, the Proctorial committee unanimously recommends as under:

1. THAT ALL THE ABOVE STUDENTS AGAINST WHOM THE SECURITY COMPLAINT/REPORT RECEIVED MAY BE DIRECTED TO APPEAR BEFORE THE PROCTORIAL COMMITTEE THROUGH THEIR RESPECTIVE HEADS, IN ITS NEXT MEETING TO BE HELD AS AND WHEN DECIDED, ALONG WITH THEIR PARENTS.
2. TO AVOID SUCH SITUATIONS IN FUTURE, THE CHIEF SECURITY OFFICER NEEDS TO EXPEDITIOUSLY DEVELOP ADEQUATE PARKING NEAR EACH ENTRANCE OF THE UNIVERSITY ESTABLISHING LIAISON WITH THE EXECUTIVE ENGINEER OF THE UNIVERSITY.

The meeting ended with a vote of thanks to the Chair.



## Proceedings of the meeting of the Proctorial Committee.

The meeting of the Proctorial Committee was held on 04.05.2023 at 03:00 PM in the office of the Proctor. The following issues came up for discussion:

1. The Proctorial Committee considered the complaint dated 22.03.2023 filed by Mr. Gobind, Research Scholar, Dept. of Ancient Indian History, KUK against fellow Research Scholar named Mr. Sumit, duly forwarded by the Chairperson of the Department, vide which it is stated that Mr. Sumit misbehaved and threaten to him when he was seated with another fellow Research Scholar, Mr. Suresh in Computer Lab. of the Department and requested to take appropriate action against him.

The Proctorial Committee deliberated on the issue in details and unanimously decided as follows:

THAT THE COMPLAINT MAY BE RETURNED TO THE CHAIRPERSON OF THE DEPARTMENT WITH THE DIRECTION TO TAKE NECESSARY ACTION AT YOUR END IN THE LIGHT OF THE POLICY/GUIDELINES DULY APPROVED BY THE HON’BLE VICE-CHANCELLOR FOR THE PURPOSE AND CIRCULATED VIDE NO. PROC/23/2003-2160 DATED 21.04.2023 AND SUBMIT YOUR REPORT TO THE OFFICE OF THE PROCTOR AT THE EARLIEST POSSIBLE.

2. The Proctorial Committee considered the security report 26.02.2023 vide which it was reported that 15-20 unknown students equipped with sticks (Lathi-Dandas) roaming in hostel premises and run away when security officials try to catch them. During this course of action, one student named Mr. Abhishek S/o Sh. Suresh, B.A.-II was found in injured state near boys’ hostel barrier, he was admitted in hospital for first aid.

Accordingly, Mr. Abhishek S/o Sh. Suresh of IHS summoned to appear before the Proctorial Committee to narrate the incident. But he did not appear before the Proctorial Committee.

The Proctorial Committee unanimously recommends as under:

THAT MR. ABHISHEK S/O SH. SURESH, B.A.-II OF IHS MAY BE PROVIDED ONE MORE OPPORTUNITY TO APPEAR BEFORE THE PROCTORIAL COMMITTEE ALONG WITH HIS PARENTS THROUGH HIS RESPECTIVE HEAD TO KNOW THE FACTUAL POSITION.

The Committee in its earlier meetings dated 02.09.2022, 05.12.2022 & 09.02.2023 considered the Security Report dated 26.07.2022 forwarded by Chief Security Officer vide diary no. 655 dated 28.07.2022 reporting that 1. Mr. Shubham Chaudhary S/o Sh. Krishan Lal, LL.B.-II, Dept. of Law 2. Mr. Vivek, outsider (as reported by the security he calls himself student of the University but had never shown his ID card even on demand), 3. Mr. Navjot Singh S/o Sh. Jasbir Singh, BTM-I of IIHS (now in MPA-I and his name was also struck off from MPA-I as reported by Chairperson, Dept. of Music & Dance), 4. Mr. Amit Kumar S/o Sh. Satpal and 5. Mr. Gurpreet Singh S/o Sh. Satnam Singh both student of MA (Public Adm.)-II, Dept. of Public Administration, KUK making nuisance in the University Campus by driving their four wheelers (Cars) rashly every time most likely during odd hours. They frequently visit without any reason on their vehicles inside and outside the campus and try to threaten the security staff on duty. The committee recommended Entry Ban mentioned at sr. no. 02-05 above being outsiders ex-students now and provided last & final opportunity to Mr. Shubham Chaudhary S/o Sh. Krishan Lal, LL.B.-II, Dept. of Law as he had not appeared before the proctorial committee in its earlier meetings even a no. of opportunities.

Accordingly, the student was directed through his respective head, well in time, finally to appear before the committee on 04.05.2023. Mr. Shubham Chaudhary S/o Sh. Krishan Lal, LL.B.-II, Dept. of Law appeared without his parents and submitted his statement verbal as well as in writing before the Proctorial Committee.

The Proctorial Committee discussed the item in detail and unanimously recommends as under:

1. THAT MR. SHUBHAM CHAUDHARY S/O SH. KRISHAN LAL, LL.B.-II, DEPT. OF LAW, KUK MAY BE IMPOSED A FINE OF RS. 15000/- IN LIEU OF ACCOMODATING THE OUTSIDER IN UNIVERSITY PREMISES.
2. THAT HIS PARENTS MAY BE INFORMED BY HIS RESPECTIVE HEAD TO APPEAR BEFORE THE PROCTORIAL COMMITTEE IN ITS NEXT MEETING, AS AND WHEN CONVENED.

4. The committee perused the recommendations of earlier meeting dated 09.02.2023 vide which Mr. Sahdev S/o Sh. Charan Dass, MPA-II student of Dept. of Music & Dance, KUK, resident of D-9, Narhari Bhawan was asked to appear before the committee alongwith his parents in its next meeting. While other involved were recommended fine and entry ban in an incident of using hukka & liquor caught during raid by Hostel Wardens.

Mr. Sahdev, who denied his presence during raid appeared before the committee again but without his parents and reiterated his version submitted during the earlier meeting of the Proctorial committee dated 05.12.2022. The Proctorial Committee perused the record received from his department and hostel i.e. Department of Music & Dance and Narhari Bhawan respectively and noted that on 15.11.2022 he was absent in classes but his presence was marked in hostel records. Regarding CCTV footage, the committee asked to the official of the office of Chief Security Officer that the CCTV footage may be sent to the Warden, Narhari Bhawan for identifying Mr. Sahdev in hostel premises on the day of raid and submit a report for perusal of Proctorial Committee. Accordingly, the Warden, Narhari Bhawan submitted his report and informed that the CCTV footage on the day of raid is not available with the office of the Chief Security Officer.

The Proctorial Committee deliberated in the matter in details and unanimously recommends as under:

THAT DUE TO NON-AVAILABILITY OF CCTV FOOTAGE WITH THE OFFICE OF CHIEF SECURITY OFFICER, MR. SAHDEV S/O SH. CHARAN DASS STUDENT OF MPA-II OF DEPT. OF MUSIC & DANCE, KUK MAY BE GIVEN BENEFIT OF DOUBT, BUT A STRICT WARNING MAY BE ISSUED TO HIM THROUGH HIS RESPECTIVE HEAD TO BE CAREFUL AND NOT REPEAT SUCH MISTAKE IN FUTURE.

5. The Committee perused recommendations of the earlier meeting dated 09.02.2023 on Security Report dated 03.12.2022 received from the Chief Security Officer vide diary no. 1018 dated 05.12.2022. Vide security report it was reported that a fight had taken place near library between two students named Ashish S/o Sh. Shiv Kumar resident of village palwa, Uchana, student of MBA and hostel resident of Arjun Bhawan (Accused) and Mr. Uday Singh S/o Sh. Mani Ram, resident of Lohar Majra, Kurukshetra student of B.Ed. 1<sup>st</sup> year (aggrieved/beatng by accused). The security staff was trying to stop the accused but all in vein and he was under influence of liquor. As per direction of Chief Security Officer, the security staff took both of them to the local police station. The Police officials detained the accused in the police station and another one was sent back with the security officials.

The security report was forwarded back to the Chief Security Officer for seeking status of police case. The office of the Chief Security Officer apprised in his report that the FIR has been registered but the accused has not been caught so far.

The Proctorial Committee, in its earlier meeting, recommended that the item be referred for its next meeting as the same be discussed in the presence of Chief Security Officer. The item is discussed in detail and unanimously decides as under:

THAT THE STUDENTS CONCERNED MAY BE DIRECTED THROUGH THEIR RESPECTIVE HEADS TO APPEAR ALONGWITH THEIR PARENTS BEFORE THE PROCTORIAL COMMITTEE IN ITS NEXT MEETING, AS AND WHEN CONVENED.

6. The Committee perused the recommendations of the earlier meeting dated 09.02.2023 on the office note of Warden Deyyani Bhawan through Chief Warden (F) dated 07.12.2022 and Security Report dated 07.12.2022 from Chief Security Officer vide diary no. 1029 dated 08.12.2022. vide office note and security report it was reported that a student named Ms. Preeti Jangra student of Mass Communication Department misbehaved with Hostel Warden, Deyyani Bhawan and unauthorized entry of boys named Mr. Bharat Brar, LLB-II, Mr. Vinod Kumar, MA (Women Studies) and two others in Girls' Hostel premises and also misbehaved with hostel warden. Ms. Preeti Jangra and Mr. Vinod Kumar appeared before the committee in its meeting dated 09.02.2023 and submitted their written. Both of them admitted their mistake and tendered their apology towards the Hostel warden and Proctorial Committee. Both Ms. Preeti Jangra and Mr. Vinod Kumar recommended for strict warning through their respective heads. Out of two other persons, one has been identified as Mr. Upkar, Dept. of Law as stated by Ms. Preeti Jangra in her statement before the committee.

Both Mr. Bharat Brar and Mr. Upkar, LLB-II were summoned to appear before the committee through their respective head. Accordingly both appeared before the committee and submitted their statements in writing.

The Proctorial committee deliberated in the matter in details and unanimously recommends as under:

7. The committee perused the recommendations of earlier meeting dated 09.02.2023 on complaint dated 24.12.2022 of Mr. Rohit S/o Sh. Surinder Pal student of MBA (4<sup>th</sup> year) in Institute of Management Studies forwarded by Chief Warden. Vide the above complaint, it was stated that on 23.12.2022 he was beaten and manhandled by some students of Mass Communication Department. All of them drunk and also accompanied with outsiders. They had physically and verbally abused him.

Accordingly, all concerned were summoned to appear before Proctorial Committee alongwith their parents through their respective heads. The complainant alongwith his father was appeared and submitted their written statement. An accused named Mr. Pushpender Yadav S/o Sh. Krishan Singh of B.Sc. (Multi-Media)-II and resident of room no. 148, Shaheed Bhagat Singh Bhawan, appeared before the committee and submitted his statement in writing. Moreover, the members of the committee watched the CCTV footage of the incident and found that a group of students constantly manhandled and slapped the complainant. A security guard was also seen in the footage and surprisingly not intervening into the matter. The Proctorial Committee recommended that Mr. Harshit Handa, Mr. Pushpender Yadav, Mr. Sahil students of IMCMT, KUK and Security official who was seen in cctv footage and not intervening in the clash may be appeared in its next meeting.

Accordingly, all accused without their parents appeared and submitted their statements in writing. Mr. Pushpender Yadav in his statement stated that threat also given to them by the friend of Mr. Rohit (complainant), owner of black Verna car having Kurukshetra district registration no. 1294 named Mr. Manish Mirzapuria. The security man concerned did not appear, as proper message was not conveyed by the o/o the Chief Security Officer to him. The Proctorial Committee also perused the subsequent complaint filed by the complainant on 25.04.2023 by requesting safety against subsequent threats by outsiders and, another request of Mr. Surinder Pal o Mr. Rohit, the complainant for early disposal of matter.

In view of the above, the Proctorial committee deliberated in the matter in details and unanimously recommends as under:

1. THAT THE PARENTS OF 1. MR. HARSHIT HANDA S/O SH. PAWAN HANDA STUDENT OF B.SC.-II (MULTI MEDIA) AND 2. MR. PUSHPENDER YADAV S/O SH. KRISHAN SINGH F B.SC. (MULTI-MEDIA)-II AND 3. MR. SAHIL STUDENT OF B.A. (MASS COMMUNICATION) BE INFORMED THROUGH THEIR RESPECTIVE HEAD TO APPEAR BEFORE THE PROCTORIAL COMMITTEE IN ITS NEXT MEETING.

Both victims have already filed FIR against the accused students immediately after the incident. Accordingly, all concerned were summoned but none of them appeared except victims, who have submitted their statements in writing. The Committee decided one more opportunity to all accused to appear before the committee.

Accordingly, all were summoned again through their respective heads and all accused appeared except Mr. Ladi Sarao and Mr. Nasib Nahra but without their parents. All appeared submitted their statements in writing.

The Proctorial Committee deliberated in details and noted that the FIR in the matter is still pending and the matter is being inquired by the Police Authorities. As the clash between both parties was occurred in University premises, hence, internal inquiry is required. Therefore, the Proctorial Committee unanimously recommends as under:

The said room no. 44 was allotted to Mr. Ravi Kumar S/o Sh. Lashkar Dass, BALLB 5<sup>th</sup> sem. under roll no. 83 of Institute of Law.

CSE 1<sup>st</sup> semester under roll no. 252202041, filed by Dr. Poonam Dabas, Centre Supdt. (A-523, UIET KUK), Dr. Ajay Jangra, Dy. Supdt. and Sh. Ajay Sharma, Centre Clerk. Vide complaint, it was apprised that the student found using unfair means during examination and UMC case was registered and his mobile phone was attached with the UMC file. Meanwhile, the student pushed the centre supdt., tried to snatch the mobile phone. Thereafter, when his father was contacted to apprise him in this regard, he also misbehaved, used abusive language and threatened of dire consequences.

Accordingly, the student concerned alongwith his father were summoned through his respective head to appear before the proctorial committee. None of them appeared on the day of meeting. Nominee of the Director, UIET who was present in the meeting apprised to the committee that the said student has himself withdrawn from the institute rolls.

The Proctorial committee condemn this unpleasant incident. As the student has already withdrawn from the institute hence, the matter would be treated as closed and ex-parte decision would be implemented. The Proctorial committee unanimously recommends as under:

Accordingly, all of them appeared before the Proctorial Committee alongwith their parents except Mr. Rajat, who appeared alongwith his uncle and submitted their contentions verbally as well as in writing. Both accused have accepted their mistake and tendered their apology verbally as well as in writing and also ready to pay all losses of Mr. Ankush which occurred due to damage cause by fire.

The Proctorial committee deliberated in the matter in details and took a serious view on this incident and unanimously recommends as under:





The meeting of the Proctorial Committee was held on 13.04.2023 at 11:00 AM in the office the Proctor. The following issues come up for discussion:

1. The Proctorial Committee considered the issue, of personal attack on a student of B.A.L.L.B. 4<sup>th</sup> Year of Institute of Law by his fellow students in Chaudhary Devi Lal Bhawan, recommended by the Anti-ragging committee and duly approved by the Hon'ble Vice-Chancellor. However, in this regard a security report dated 10.04.2023 also perused by the Proctorial Committee vide which it was reported that on 07.04.2023 during midnight some non-residents of hostels named Mr. Zoravar Malik S/o Sh. Rohtash Malik, Roll No. 63, Mr. Abhinav Bhambi S/o Sh. Hemant Kumar, Roll No. 49, Mr. Kartik Kamboj S/o Sh. Satish Kumar, Roll No. 123, Mr. Vishwas S/o Sh. Vishvnath, Roll No.114 student of B.A.L.L.B. 5<sup>th</sup> Year and Mr. Himanshu S/o Sh. Joginder Singh, Roll No. 95, B.A. L.L.B. 3<sup>rd</sup> Year and resident of room no. 39 of Ch. Devi Lal Bhawan assaulted Mr. Mayank Juglan S/o Sh. Jaswant Singh, student of B.A.L.L.B. 4<sup>th</sup> Year, roll no. 113 and Mr. Mukul Malik, student of B.A.L.L.B. 4<sup>th</sup> Year, roll no. 22, all of them are the students of Institute of Law. During this attack, Mr. Mayank Juglan was injured badly and wounds appeared in his stomach which resulted in stitches. Security officials and other fellow students/residents admitted him in hospital for first aid, thereafter, FIR against the accused persons were registered by the victim.

Accordingly, all concerned students were summoned to appear before the Proctorial Committee on 11.04.2023 at 11:00 AM through their respective head of Institute alongwith their parents. But none of accused appeared before the Proctorial Committee on 11.04.2023. Mr. Jiten Yadav, student of B.A.L.L.B. 5<sup>th</sup> Year, who is the witness in the matter, appeared on 11.04.2023 and submitted his statement in writing. It is pertinent to mention here that both victims and two other witnesses appeared on 10.04.2023 and submitted their statement in writing. After detailed deliberations in the matter, the Proctorial Committee recommended another opportunity to the accused students and resident of room no. 39 named Mr. Manpreet S/o Sh. Tarsem Singh, B.A.L.L.B. 3<sup>rd</sup> Year, who accommodated the outsiders in his room and who had also taken liquor in his room, alongwith their parents through their respective head to appear before the Proctorial Committee on

13.04.2023 at 11:00 AM with the stipulation that failing to do so, ex-parte decision will be taken against them.

Accordingly, all concerned students alongwith their parents were summoned through their respective head to appear before the Proctorial Committee on 13.04.2023 at 11:00 AM. All of them appeared before the Proctorial Committee without their parents except Mr. Zoravar Malik, who appeared alongwith his father. All of them submitted their contentions before the committee verbally as well as in writing.

Moreover, the Proctorial Committee noted that Mr. Zoravar Malik S/o Sh. Rohtash Malik, Roll No. 63 and Mr. Abhinav Bhambi S/o Sh. Hemant Kumar, Roll No. 49, B.A.LL.B. 5<sup>th</sup> Year already banned after 06:00 PM in University premises vide Endst. No. ACM-I/St.6/23/216-233 dated 09.01.2023 and they breach the earlier orders by entering the hostel premises whereas their entry in the University premises was banned.

The Proctorial committee assures the parents of the victim about safety and security of the student and condemn this unpleasant incident. The committee took a serious view on this incident and unanimously recommends as under:

1. THAT (i) MR. ZORAVAR MALIK S/O SH. ROITASH MALIK, ROLL NO. 63, (ii) MR. ABHINAV BHAMBI S/O SH. HEMANT KUMAR, ROLL NO. 49, (iii) MR. KARTIK KAMBOJ S/O SH. SATISH KUMAR, ROLL NO. 123, (iv) MR. VISHWAS S/O SH. VISHVNATH, ROLL NO.114 STUDENT OF B.A.LL.B. 5<sup>th</sup> YEAR, (v) MR. HIMANSHU S/O SH. JOGINDER SINGH, ROLL NO. 95 AND (vi) MR. MANPREET S/O SH. TARSEM SINGH, B.A.LL.B. 3<sup>rd</sup> YEAR, WHO ACCOMMODATED THE OUTSIDERS IN HIS ROOM MAY BE SUSPENDED AND THEIR ENTRIES BE BANNED WITH IMMEDIATE EFFECT IN THE UNIVERSITY PREMISES.

3. THAT MR. HIMANSHU S/O SH. JOGINDER SINGH, ROLL NO. 95 AND MR. MANPREET S/O SH. TARSEM SINGH, STUDENTS OF B.A.LL.B. 3<sup>rd</sup> YEAR WHO ACCOMMODATED THE OUTSIDERS IN THEIR ROOM MAY BE FINED OF RS. 15000/- EACH AND EXPELLED FROM THE UNIVERSITY HOSTELS.
4. THAT THEIR NAMES WITH PROPER ADDRESS AND PHOTOGRAPH MAY BE PROVIDED BY THE DIRECTOR, INSTITUTE OF LAW TO THE OFFICE OF THE CHIEF SECURITY OFFICER TO ENSURE THEIR ENTRY BAN.
5. THAT THEIR NAMES MAY BE DISPLAYED ON NOTICE BOARD OF INSTITUTE OF LAW AND ALL HOSTELS. IF ANY HOSTEL RESIDENT WILL FOUND ACCOMODATING THEM IN THEIR ROOM, HE WILL ALSO BE EXPELLED FROM HOSTEL WITHOUT ANY ENQUIRY. IF ANYONE SEEM THE ABOVE STUDENTS IN UNIVERSITY PREMISES, MAY INFORM THE SECURITY OFFICE ON NUMBER 7082113077 IMMEDIATELY.

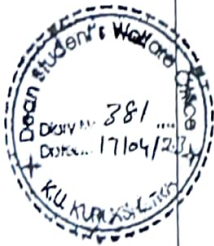

A meeting of the Proctorial Committee held on 05.12.2022 at 03:00 PM in the office the Proctor. The following issues come up for discussion:

1. The committee perused the security report dated 16.09.2022 forwarded by Chief Warden (Male) on 19.09.2022 vide which it was reported that on 15.09.2022 during midnight a clash between two groups were taken place in Narhari Bhawan and during this incident two persons were badly injured and hospitalized. One out of both injured named Mr. Randeep Singh who is employed as T. Mate (on contract under Haryana Kausal Rozgar Nigam Ltd. as informed by XEN in his comments vide letter dated 03.10.2022) in Construction Branch of this University.

Mr. Randeep Singh was summoned through his respective head to appear before the Proctorial committee on 05.12.2022. Accordingly, he appeared and submitted his version before the proctorial committee in writing by stating that on the day of incident, he was waiting for his cousin in park area of Narhari Bhawan and 4-5 unknown persons came and hit him without any reason. He was admitted in hospital by his whereabouts. Now, the matter has been settled in police station between both parties.

The Proctorial committee deliberated in the matter in details and is of the considered view that these types of incidents are not good for University environment. Hence, the Committee unanimously decides as under:

**THAT THE CASE BE CLOSED AS THE MATTER WAS TAKEN UP BY POLICE AUTHORITIES AND SETTELED BETWEEN BOTH PARTIES. HOWEVER, THE COMMITTEE WAS OF UNANIMOUS VIEW THAT MR. RANDEEP SINGH MAY BE ADVISED THROUGH HIS RESPECTIVE HEAD TO REFRAIN FROM ROAMING IN UNIVERSITY HOSTELS DURING ODD HOURS WITHOUT ANY REASON.**

2. The Committee in its earlier meeting dated 02.09.2022 considered the Security Report dated 26.07.2022 forwarded by Chief Security Officer vide diary no. 655 dated 28.07.2022 vide which it was reported that 1. Mr. Shubham Chaudhary S/o Sh. Krishan Lal, LL.B.-I, Dept. of Law 2. Mr. Vivek, outsider (as reported by the security he calls himself student of the University but never ever show his ID

card even on demand), 3. Mr. Navjot Singh S/o Sh. Jasbir Singh, BTM-I of IIHS (now in MPA-I and his name was also struck off from MPA-I as reported by Chairperson, Dept. of Music & Dance), 4. Mr. Amit Kumar S/o Sh. Satpal and 5. Mr. Gurpreet Singh S/o Sh. Satnam Singh both student of MA (Public Admn.)-II, Dept. of Public Administration, KUK making nuisance in the University Campus by driving their four wheelers (Cars) rashly every time most likely during odd hours. They frequently visit without any reason on their vehicles inside and outside the campus and try to threaten the security staff on duty. The committee decided that all the above students to be directed to appear before the proctorial committee in its next meeting alongwith their parents.

None of them except Mr. Navjot Singh, MPA-I (now outsider as his name struck off from the department) appeared before the committee and tendered his apology in writing. The committee noted that Mr. Amit Kumar S/o Sh. Satpal and Mr. Gurpreet Singh S/o Sh. Satnam Singh both student of MA (Public Admn.)-II, Dept. of Public Administration, KUK passed out from the department, as informed by Chairperson, Dept. of Public Administration before the committee.

In view of the above facts, the Proctorial committee unanimously recommends as under:

1. THAT THE ENTRY OF 1. MR. VIVEK, OUTSIDER, 2. MR. NAVJOT SINGH S/O SH. JASBIR SINGH, MPA-I, NOW OUTSIDER, 3. MR. AMIT KUMAR S/O SH. SATPAL AND 4. MR. GURPREET SINGH S/O SH. SATNAM SINGH BOTH EX-STUDENT OF MA (PUBLIC ADMN.)-II, ALSO BOTH OUTSIDERS NOW, BE BANNED IN UNIVERSITY CAMPUS WITH IMMEDIATE EFFECT.
2. THAT MR. SHUBHAM CHAUDHARY S/O SH. KRISHAN LAL, LL.B.-I, DEPT. OF LAW, KUK BE DIRECTED FINALLY THROUGH HIS RESPECTIVE HEAD TO APPEAR BEFORE THE PROCTORIAL COMMITTEE IN ITS NEXT MEETING ALONGWITH HIS PARENTS FAILING WHICH EX-PARTE DECISION WILL BE TAKEN.

3. The committee perused the security report dated 15.11.2022 received from office of the Hon'ble Vice-Chancellor vide diary no. 4814 dated 16.11.2022 vide which it was reported that on 15.11.2022 during night time a raid was conducted by Hostel Wardens in Narhari and Ch. Devi Lal Bhawan hostels and some students were found with Hukka and taking liquor in room no. D-9 & D-25 in Narhari Bhawan. Similarly, some students were found celebrating party with outsiders in room no. 49 of Ch. Devi Lal Bhawan. When hostel wardens knocked the door, they did not respond and ran away. The matter was forwarded to Chief Warden (M) for his specific comments. The Chief Warden (M) reported that the resident of room no. D-25 of Narhari Bhawan had apologized, deposited fine of Rs. 1500/- and submitted an undertaking for good conduct. Concerned residents of above hostels and outsiders were summoned for appearing before the committee through their respective heads.

All of them named 1. Mr. Sahdev S/o Sh. Charan Dass, MPA-II student of Dept. of Music & Dance, KUK, resident of D-9, Narhari Bhawan, 2. Mr. Gaurav Rathi S/o Sh. Basan Singh, BALL.B.-II, 3. Mr. Harsh S/o Sh. Suresh Kumar, BALL.B.-II, 4. Mr. Sahil S/o Sh. Suraj Bhan, BALL.B.-II, residents (sr. no. 2-4) of room no. 49 of Ch. Devi Lal Bhawan, 5. Mr. Abhinav, BALL.B. Final Year, 6. Mr.

Final Year (sr. no. 5-7 outsiders) all (sr. no. 2-7) students of Institute of Law, KUK, appeared before the Proctorial committee without their parents except Mr. Sahil at sr. no. 4 who appeared alongwith his father and submitted their version in writing.

Mr. Sahdev at sr. no. 1 denied his presence at the time of raid conducted by hostel warden on 15.11.2022. All students at sr. no. 2 to 7 (residents and outsiders) accepted that they were present in the room no. 49 of Ch. Devi Lal Bhawan at the time of raid but denied taking any intoxicating material in their room.

The Proctorial committee deliberated in the matter in details and is of the considered view that the resident students were accommodating the outsiders at their room during late hours which is not permissible in any manner and may be dealt as per guidelines already passed and circulated among students earlier. Hence, the Committee unanimously decides as under:

1. THAT MR. SAHDEV S/O SH. CHARAN DASS, MPA-II STUDENT OF DEPT. OF MUSIC & DANCE, KUK AND RESIDENT OF D-9, NARHARI BHAWAN, WHO DENIED HIS PRESENCE AT THE TIME OF RAID, MAY BE DIRECTED THROUGH HIS RESPECTIVE HEAD, TO APPEAR IN NEXT MEETING OF PROCTORIAL COMMITTEE ALONGWITH HIS PARENTS. MOREOVER, CHAIRPERSON, DEPT. OF MUSIC & DANCE, CHIEF SECURITY OFFICER AND HOSTEL WARDEN MAY PROVIDE THE ANTECEDENTS & ATTENDANCE RECORD, CCTV FOOTAGE AND HOSTEL RECORD OF 15 & 16 NOVEMBER, 2022 RESPECTIVELY TO THE OFFICE OF PROCTOR.

Accordingly, both parties i.e. complainant and accused were called to appear before the proctorial committee alongwith their parents through their respective heads and all of them appeared except friend of accused named Mr. Vishal, an outsider.

A meeting of the Proctorial Committee was held on 09.02.2023 at 03:00 PM in the office the Proctor. The following issues come up for discussion:

1. The Committee in its earlier meetings dated 02.09.2022 & 05.12.2022 considered the Security Report dated 26.07.2022 forwarded by Chief Security Officer vide diary no. 655 dated 28.07.2022 reporting that 1. Mr. Shubham Chaudhary S/o Sh. Krishan Lal, LL.B.-I, Dept. of Law 2. Mr. Vivek, outsider (as reported by the security he calls himself student of the University but had never shown his ID card even on demand), 3. Mr. Navjot Singh S/o Sh. Jasbir Singh, BTM-I of IIHS (now in MPA-I and his name was also struck off from MPA-I as reported by Chairperson, Dept. of Music & Dance), 4. Mr. Amit Kumar S/o Sh. Satpal and 5. Mr. Gurpreet Singh S/o Sh. Satnam Singh both student of MA (Public Admn.)-II, Dept. of Public Administration, KUK making nuisance in the University Campus by driving their four wheelers (Cars) rashly every time most likely during odd hours. They frequently visit without any reason on their vehicles inside and outside the campus and try to threaten the security staff on duty. The committee recommended Entry Ban mentioned at sr. no. 02-04 above being outsiders/ex-students now and provided one more opportunity to Mr. Shubham Chaudhary S/o Sh. Krishan Lal, LL.B.-I, Dept. of Law as he had not appeared before the proctorial committee in its meeting dated 05.12.2022. The recommendations of the Proctorial Committee were approved by the Hon'ble Vice-Chancellor and circulated to all concerned. Accordingly, the student was directed through his respective head, well in time, to appear before the committee on 09.02.2023.

But Mr. Shubham Chaudhary S/o Sh. Krishan Lal, LL.B.-I, Dept. of Law did not turn up. The Proctorial committee discussed the item in detail and decides final opportunity may be provided to Mr. Shubham Chaudhary S/o Sh. Krishan Lal to appear before the Proctorial Committee alongwith their parents in its next meeting.

In view of the above, the Proctorial committee unanimously recommends as under:

**THAT MR. SHUBHAM CHAUDHARY S/O SH. KRISHAN LAL, LL.B.-I, DEPT. OF LAW, KUK BE DIRECTED FINALLY THROUGH HIS RESPECTIVE HEAD TO APPEAR BEFORE THE PROCTORIAL COMMITTEE IN ITS NEXT MEETING ALONGWITH HIS PARENTS FAILING WHICH EX-PARTE DECISION WILL BE TAKEN.**

2. The committee perused the recommendations of earlier meeting dated 05.12.2022. Vide which Mr. Sahdev S/o Sh. Charan Dass, MPA-II student of Dept. of Music & Dance, KUK, resident of D-9, Narhari Bhawan was asked to appear before the committee alongwith his parents in its next meeting. While other involved were recommended fine and entry ban in an incident of using hukka & liquor caught during raid by Hostel Wardens.

Mr. Sahdev, who denied his presence during raid appeared before the committee again but without his parents and reiterated his version submitted during the earlier meeting of the Proctorial committee dated 05.12.2022. The Proctorial Committee perused the record received from his department and hostel i.e. Department of Music & Dance and Narhari Bhawan respectively and noted that on 15.11.2022 he was absent in classes but his presence was marked in hostel records. Regarding CCTV footage, the committee asked to the official of the office of Chief Security Officer that the CCTV footage may be sent to the Warden, Narhari Bhawan for identifying Mr. Sahdev in hostel premises on the day of raid.

The Proctorial Committee deliberated in the matter in details and unanimously recommends as under:

**THAT THE CCTV FOOTAGE MAY BE SENT BY THE OFFICE OF CHIEF SECURITY OFFICER TO THE WARDEN, NARIHARI BHAWAN FOR IDENTIFYING MR. SAHDEV IN HOSTEL PREMISES ON THE DAY OF RAID AND REPORT MAY BE SUBMITTED IN NEXT PROCTORIAL COMMITTEE MEETING.**

3. The Committee perused the Security Report dated 03.12.2022 received from the Chief Security Officer vide diary no. 1018 dated 05.12.2022 vide which it was reported that a fight had taken place near library between two students named Ashish S/o Sh. Shiv Kumar resident of village palwa, Uchana, student of MBA and hostel resident of Arjun Bhawan (Accused) and Mr. Uday Singh S/o Sh. Mani Ram, resident of Lohar Majra, Kurukshetra student of B.Ed. 1<sup>st</sup> year (aggrieved/beatng by accused). The security staff was trying to stop the accused but all in vein and he was under influence of liquor. As per direction of Chief Security Officer, the security staff took both of them to the local police station. The Police officials detained the

accused in the police station and another one was sent back with the security officials.

The matter was forwarded back to the Chief Security Officer for seeking status of police case. The office of the Chief Security Officer apprised in his report that the FIR has been registered but the accused has not been caught so far.

The Proctorial Committee deliberated in details on the item and decides that the item may be referred to the next meeting as Chief Security Officer/Dy. Chief Security Officer is not present in the meeting and his presence is mandatory to decide these matters and recommends.

**THAT THE ITEM BE REFERRED FOR NEXT MEETING AND TO BE DICUSSED IN THE PRESENCE OF CHIEF SECURITY OFFICER/DY. CHIEF SECURITY OFFICER.**

4. The Committee perused the office note of Warden Devyani Bhawan through Chief Warden (F) dated 07.12.2022 and Security Report dated 07.12.2022 from Chief Security Officer vide diary no. 1029 dated 08.12.2022 vide which it was reported that a student named Ms. Preeti Jangra student of Mass Communication Department misbehaved with Hostel Warden, Devyani Bhawan and unauthorized entry of boys named Mr. Bharat Brar, LLB-II, Mr. Vinod Kumar, MA (Women Studies) and two others in Girls' Hostel premises and also misbehaved with hostel warden. Accordingly, all of three students were summoned to appear before the proctorial committee alongwith their parents through their respective heads.

Ms. Preeti Jangra and Mr. Vinod Kumar appeared before the committee without their parents and submitted their version verbally as well as in writing before the committee. Both of them admitted their mistake and tendered their apology towards the Hostel warden and Proctorial Committee. Out of two unnamed persons, one has been identified as Mr. Upkar, Dept. of Law as stated by Ms. Preeti Jangra in her statement before the committee. The members of the Proctorial Committee confirmed the incident by watching the CCTV footage of the incident.

The Proctorial committee deliberated in the matter in details and unanimously decides as under:

1. THAT 1. MS. PREETI JANGRA D/O SH. PAWAN KUMAR, M.SC. (PRINTING, GRAPHICS & PACKAGING TECHNOLOGY) AND 2. MR. VINOD KUMAR S/O SH. SURESH, MA (WOMEN STUDIES) BE ISSUED A STRICT WARNING THROUGH THEIR RESPECTIVE HEAD NOT TO REPEAT SUCH MISTAKE IN FUTURE.

5. The committee perused the complaint dated 24.12.2022 of Mr. Rohit S/o Sh. Surinder Pal student of MBA (4<sup>th</sup> year) in Institute of Management Studies forwarded by Chief Warden alongwith the report of Warden, Shaheed Bhagat Singh Bahwan. Vide the above complaint, it is stated that on 23.12.2022 he was beaten and manhandled by some students of Mass Communication Department. All of them drunk and also accompanied with outsiders. They had physically and verbally abused him. The same has been ratified by the Warden, Shaheed Bhagat Singh Bahwan in his report.

Accordingly, all concerned were summoned to appear before Proctorial Committee alongwith their parents through their respective heads. Mr. Rohit, the complainant has appeared alongwith their parents before the committee and submitted their contentions verbally as well as in writing. Out of two accused, whose names have been revealed in complaint, i.e. Mr. Harshit Handa S/o Sh. Pawan Handa and Mr. Pushpender Yadav S/o Sh. Krishan Singh both student of B.Sc. (Multi-Media)-II and resident of room no. 148, Shaheed Bhagat Singh Bahwan, one named Mr. Pushpender Yadav appeared before the committee and submitted his statement in writing. In this statement, he revealed the name of one another student named Mr. Sahil student of B.A. (Mass Communication) and resident of room no. 157 of Shaheed Bhagat Singh Bahwan. Mr. Harshit Handa found exemption for appearance in this meeting due to marriage ceremony of her sister as per his request duly forwarded by the Director, Inst. of Mass Communication & Media Technology, KUK. Moreover, the members of the committee watched the CCTV footage of the incident and found that a group of students constantly manhandled and slapped the complainant. A security guard was also seen in the footage and surprisingly not intervening into the matter.

The Proctorial committee deliberated in the matter in details and is of the considered view that this type of untoward incident is highly condemnable and will not be tolerated in any manner. The Proctorial committee assured the parents of the victim that Kurukshetra University Campus has a zero tolerance campus and safety of the students is highly sensitive matter to us. Hence, the Committee unanimously decides as under:

1. THAT 1. MR. HARSHIT HANDA S/O SH. PAWAN HANDA STUDENT OF B.SC.-II (MULTI MEDIA) AND 2. MR. SAHIL STUDENT OF B.A. (MASS COMMUNICATION) & RESIDENT OF ROOM NO. 157 OF SHAHEED BHAGAT SINGH BHAWAN BE DIRECTED THROUGH THEIR RESPECTIVE HEAD TO APPEAR BEFORE THE PROCTORIAL COMMITTEE ALONGWITH THEIR PARENTS IN ITS NEXT MEETING.

**ANTI-RAGGING COMMITTEE REPORT**

**Action taken report of an emergent meeting of the Anti-Ragging Committee held on 10.04.2023 at 01:00 p.m. in the office of the Proctor, Kurukshetra University, Kurukshetra.**

---

**(i) Details of Investigation done by anti-ragging Committee members:**

A complaint of ragging received on 09.04.2023 at 01:44 PM through e-mail from Anti Ragging Helpline vide Ref No. HR\_0016 in the office of Proctor. Thereafter, the same has been forwarded by the office of the Vice-Chancellor and Registrar, KUK in the office of Proctor against Mr. Zoravar Malik S/o Sh. Rohtash Malik, Roll No. 63, Mr. Abhinav Bhambi S/o Sh. Hemant Kumar, Roll No. 49, Mr. Kartik Kamboj S/o Sh. Satish Kumar, Roll No. 123, Mr. Vishwas S/o Sh. Vishvnath, Roll No.114 student of B.A.LL.B. 5<sup>th</sup> Year and Mr. Himanshu S/o Sh. Joginder Singh, Roll No. 95, B.A. LL.B. 3<sup>rd</sup> Year, Institute of Law, Kurukshetra University, Kurukshetra.

First of All, soon after receiving the email on 09.04.2023 from Anti-Ragging Helpline, the Anti-ragging committee made earnest efforts to identify the victim. The probable victim was identified at 10.30 am on 10.04.2023 and counselled by our counselor so that the victim would feel good and remain out of stress. The matter was discussed in detail with the victim by the anti-ragging committee and he confirmed that he had filed a complaint through email at the anti-ragging helpline of UGC. Further, during detailed investigation, Mr. 'X' (victim) told the committee that it is a case of personal attack by the above mentioned student further adding that he perceive it as a matter of ragging as there is no incident of such type which occurred prior to this. During the detailed investigations, Mr. 'X' (victim) also failed to provide any substantial proof of ragging with him to the committee. The committee allowed him to submit his version in writing.

So, after carefully examining the case, due verification of the contents of the complaint made by Mr. 'X' (victim), in the absence of any circumstantial or substantial evidence and also going through the statement and assertion tendered by the victim, the Committee is unable to constitute it a case of ragging against Mr. 'X' (victim) and treated it as a case of personal attack between Mr. 'X' and the accused students.



**(ii) Conclusions of the Investigations:**

After carefully examining the case, due verification of the contents of the complaint made by Mr. 'X' (victim), in the absence of any circumstantial or substantial evidence and also going through the statement and assertion tendered by the victim, the Committee is unable to constitute it a case of ragging against Mr. 'X' (victim) and treated it as a case of personal attack between Mr. 'X' and the accused students.
