[C] Redressal of Grievances by Proctorial Committee: Disciplinary Action on students' grievances and complaints is taken up in the meetings of Proctorial Committee. The ragging complaints are also handled by Proctorial Committee which are resolved within 24 hours of receiving the complaint. The cases other than ragging are also timely resolved within 90 days except for few cases where either complainant or accused fails to appear before the committee.
