Act & Statutes, 1986 in anticipation of approval of the Academic Council/Executive Council in approving the draft Ordinance for Undergraduate and Post graduate Programmes in Special Education (B.Ed.Spl.Ed. (VI) and M.Ed.Spl.Ed.(VI) based on Curriculum and Credit Framework of Rehabilitations Council of India (RCI) applicable w.e.f. the Session 2024-25 as per [Annexure Pages 25\(1-18\)](#).

**STATEMENT OF THE CASE**

The draft Ordinance for Undergraduate and Post graduate Programmes in Special Education (B.Ed.Spl.Ed. (VI) and M.Ed.Spl.Ed.(VI) based on Curriculum and Credit Framework of Rehabilitations Council of India (RCI) supplied by the Chairperson, Department of Education has been considered and recommended by the Standing Ordinance Committee in its meeting held on 26.12.2024.

Since meeting of the Academic Council was not being held shortly and the above Ordinance was to be implemented w.e.f the Session 2024-25, the Vice-Chancellor took the above action.

- (i) approving the recommendations of the Committee in its meeting held on 26.12.2024 regarding allowing permission to students/residents belonging to State of Haryana for appearing in additional teaching subject (s) of B.Ed./B.Ed. (Special Education) (V.I).
  - (ii) Consequential amendments/additions to Clause 19 of the Ordinance for Bachelor of Education (B.Ed.) 2 Year Examination (under CBCS/LOCF) and Bachelor of Education in Special Education (V.I.) w.e.f. the Session 2024-25 (**Annexure Pages as per 26(1-17)**).

#### **STATEMENT OF THE CASE**

Some request (s) were submitted by residents belonging to State of Haryana for allowing to appear in the B.Ed. (Additional) examination in the University, who have passed their B.Ed./B.Ed. Special Education (V.I.) from any State Universities of India as per past practice. Later on, similar request (s) submitted by Mr. Amit Soni, Jaiveer Singh & 42 others and a complaint submitted by Ms. Indu Bala & 42 was received from Secretary to Governor Haryana. The same was examined by the committee in its meeting held on 8.8.2024 and 17.09.2024.

In the meantime, another request under reference submitted by Ms. Indu Bala W/o Sh. Ajit Singh VPO Bapora, Bhiwani before CM Window was sent by the o/o the Director General Higher Education, Haryana, Panchkula vide Memo.No.18/226-2024 UNP (3) dated 25.11.2024 (**Annexure Pages as per 26(9)**) with the request to submit the report/comments.

Accordingly, the matter was re-examined by the Committee under the Chair of the Dean Academic Affairs in its meeting held on 26.12.2024 and it was recommended that the students having passed B.Ed./B.Ed.(Special Education) (V.I.) from Kurukshetra University/Any other State University of Haryana/Other than State University of Haryana as per NCTE/RCI guidelines may be allowed to appear in one/two additional teaching subject (s) of B.Ed./ B.Ed.(Special Education (V.I.) examination with prescribed fee, if otherwise eligible, as per prevailing Ordinance and Scheme/Syllabi and consequential amendments/additions may be made in the Ordinance for Bachelor of Education (B.Ed.) 2 Year Examination (under CBCS/LOCF) and Bachelor of Education B.Ed. (Special Education) (V.I.) w.e.f. the Session 2024-25 as per **Annexure Pages as per 26(1-2)**.

Since meeting of the Academic Council was not being held shortly and the above provision was to be made applicable w.e.f the Session 2024-25, the Vice-Chancellor took the above action.
