No. 40 dated 24.07.2020, Res. No. 16 dated 30.12.2022, Res. No. 35 dated 22.08.2023 and Res. No.24 dated 04.03.2024, for the following positions:

iv)	Assistant Professor (Academic Level-11 to Academic Level-12)	under Self-Financing Scheme.  From Assistant Professors (AL-11) working against sanctioned budgeted posts as well as those working under Self Financing Scheme.
v)	Assistant Professor (Academic Level-10 to Academic Level-11)	From Assistant Professors (AL-10) working against sanctioned budgeted posts as well as those working under Self-Financing Scheme.

In case the applicant is a Chairperson/Director, then the application will be forwarded by the Dean of concerned Faculty. In case the applicant is a Chairperson/Director as well as Dean of the Faculty, then the application will be forwarded directly by the concerned teacher as a Dean, Faculty to the Establishment Branch.
2)	In case of promotion under CAS upto the posts of Professor (Academic Level- 14)	i.	If the applicant is a Chairperson/Director, then the contents of the Table-1 of the application form will be verified by the Senior Most Professor of the Department/Institute.  When there is no Professor available in the Department/Institute and Chairman/Director is an applicant, then a committee of three Professors, constituted by the Dean of the concerned Faculty, will verify the contents of the Table-1 of the application form.

A three-member committee consisting of Dean, Faculty of Arts &amp; Languages, Senior most Professor and next Senior Professor of the Library and Information Science Department will verify the contents of the Table-1 of the application form.</li> <li>ii. In case, when there is only one Professor in the Department of Library and Information Science, then Dean of Faculty concerned may co-opt one Professor from other department in the above mentioned committee.</li> <li>iii. In case, when there is no Professor in the department of Library and Information Science, then the Dean of concerned Faculty may co-opt two senior Professors from other departments in the above-mentioned Committee.
