17. Multidisciplinary / interdisciplinary

Founded in 1956 as a center for higher learning in Sanskrit and Indian studies, Kurukshetra University is currently a multi-faculty, multidisciplinary center of higher education. Being the oldest university in the state of Haryana, it has always been in the forefront of developing newer methods for research, teaching, student support, administration, and extension operations. The University gives its students the knowledge, perspectives, dispositions, and real-world experience they need to become astute citizens. The University envisages to be globally acknowledged as distinguished center of academic excellence and has a mission to prepare a class of proficient scholars and professionals with ingrained human valued and commitment to expand the frontiers of knowledge for the advancement of society. In order to realize this vision and mission, the University has a multifaceted strategies for the holistic development of the students. Commending with the academic, the University is implementing NEP-2020 in its true sprit with a focus on up scalling and instilling a multi disciplinary learning of their respective academic programmes. Students have flexibility of learning and there is a provision for multiple entry and exit during their perusing the degree programmes. While specializing in the respective stream, the students have to learn a subject from other discipline which helps in developing a multidisciplinary understanding of their own subjects, supporting creative and critical thinking.

18.Academic bank of credits (ABC):

The UGC norms 2021 pertaining to the creation of Academic Banks of Credits (ABC) in higher education have been approved by the university. Now the students of Kurukshetra University are link with the Academic Bank of Credit which is functional under the aegis of the Ministry of Education, Govt. of India. The University has been registered with ABC after meeting the requirements for registration. Students, especially those from overseas, are urged and assisted to register on ABC. In order to prevent any delays in the transfer of credits, it is now required of the students to include their ABC registration on the test forms. The student's academic credits will be digitally saved by ABC so that the credits will be taken into consideration when degrees are conferred. A student's account at ABC may also receive credits from other HEIs, which may then be applied toward the awarding of a degree, diploma, or certificate. The departments are implementing the ABC and are monitoring the registration process of the students in the academic bank.

19.Skill development:

The University has taken several initiatives for the skill development and entrepreneurship development among the students. It has established six training centres including Centre for Skill Development, Centre for Enterpreneurship, Corporate Resource Centre, Centre for Continuing Education, Incubation Centre, Centre for IT and Automation and Centre for Sports. More than 3000 trainees have been benefitted by these centres through skill development The University has organized more than 36 events for programmes. capacity development and skill enhancement of students during the year 2022-23. During the academic year 2022-23, 14 MoUs have been signed with various professional bodies and the industry to strengthen the training for skill development. In sprit of the NEP-2020, bachelors programme has been implemented in Institute of Integrated and Honours Studies. The curricula of this programme has been designed to include Skill Development courses in each programme. Some of the key highlights of the programmes are: Ability Enhancement compulsory courses in language communication and Environmental science. Skill enhancement/development courses in Computer science, personality development, community engagement, working with incubation centre at university campus are offered from the very first semester the programme so that the students opting for exit after one year of study are also equipped with basic skills. Subject specific skill Enhancement/development courses Along with generic skill enhancement courses every student will acquire skills in the subject of study through skill enhancement courses in the subjects in third year of study. Activity courses are offered to develop soft skills, such as complex problem solving, critical thinking, Communication skills; and skills in music, dance, drama, sports, artificial intelligence, gaming, block chain technology, web designing, banking, financial literacy etc.

20.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Situated on the banks of Bram Sarovar in the holy city of Kurukshetra, Kurukshetra University has a natural ora where in teaching of Srimad Bhagavada Gita are enshrined. This connects the present generation to its glorious past traditions of knowledge. Department of Sanskrit, Pali & Prakrit was the first postgraduate department to be established in 1956 and offers 4 groups of specialization including Vedic Studies and Indian Philosophy. Since 2014, International Gita Seminar has been organised every year in which learned scholars from India and abroad participated. There were over 500 registrations and technical sessions were organised by various departments integrating their respective streams of knowledge with message of Bhagavada Gita. Department of Youth and Cultural Affairs organizes a cultural program every year, at Brahmsarover, Kurukshetra on the occasion of Gita JayantiUtsav-a national level festival spreading the message of Gita and displaying art, craft & culture of various states of India. In order to the connect the academic learning with the deep routed traditional wisdom the University offers the following: Students have option to take examinations in Hindi as well as English in all programmes being offered by Kurukshetra University. Courses are offered in Indian value system, Haryana Culture and Heritage, Indian heritage and tourism, Medicinal flora of Haryana to integrate Indian knowledge system with formal education to make it holistic and connected to roots. Value added courses in Human values and Ethics, teachings of Gita, constitutional ethics, Business ethics are offered for the holistic development of the students. The University is offering certificate course in Yoga, Diploma in Yoga and Applied philosophy, P.G. diploma courses in Buddhist studies, Yoga to integrate the students with Indian knowledge. Students are given option to complete 40% of the courses in online mode. Options to study online subject specific and generic courses are given. Kurukshetra University has started UG programmes and some courses in online mode. Students can choose to study some courses from online platforms including that of Kurukshetra University. The distinctive "Dharohar," the Haryana Museum of Kurukshetra University, has preserved the rich and diverse cultural heritage of Haryana. Its significance is increased by the fact that it is situated on a university campus, which allows visitors and students alike to have an enhanced understanding of Haryana's dynamic culture. The Museum is upholding its social, spiritual, and ethical duties to honor the customs, beliefs, and cultural knowledge of the Haryana people. The University has opened a museum honoring the "First War of Independence 1857," with a special emphasis on the part played by the people of Haryana in it, to mark the event's 150th anniversary of the first war of Independence

21.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

The University has conducted a thorough exercise to integrate the Choice Based Credit System Learning Outcome based Curricula Framework (CBCS-LOCF) for all academic programs on campus beginning in the 2020-21 academic year in order to keep up with the rapidly changing times. All of the programs have declared their course outcomes (COs), program specific outcomes (PSOs), and program outcomes (POs). A framework for gauging attainment levels has also been developed and put into practice. The outcomes of internal assessments and semester are used to gauge the attainment of COs. Keeping pace with the fast changing time, the University has done a comprehensive exercise to implement Choice Based Credit System Learning Outcome based Curricula Framework (CBCS-LOCF) for all the academic programmes of the Campus w.e.f the session 2020-21. The Programme Outcomes (POs), Programme Specific Outcomes (PSOs) and Course Outcomes (COs) have been stated for all the programmes and a policy for measuring the attainment levels has also been framed and implemented.The attainment of COs is measured on the basis of the results of internal assessment and semester

22.Distance education/online education:

Kurukshetra University's Directorate of Distance Education (DDE) is the first institution in Haryana to provide high-quality education over the past 36 years. It supports thousands of students who are either unable to pursue their academic goals because of financial limitations or who want to improve their credentials and level of proficiency. The goal of the University's DDE is to provide highquality education to learners at their doorstep, thus achieving the unattainable goal of creating a knowledge society. 39 programs, including certificate, diploma, post-diploma, and master's programs, are offered by the DDE. Online Degree programmes in Commerce & Management have been offered to the students.

1.1 - Curriculum Design and Development

Kurukshetra University is dedicated to offering higher education across all academic disciplines. As the oldest university in Haryana, the institution has consistently been at the forefront of trying out improved methods of teaching and learning. The University consists of 10 faculties and 49 departments/ institutes, offering a wide range of academic disciplines and areas of study. The University provides UG, PG, and Ph.D. courses in various fields such as Science, Life Sciences, Engineering, Arts and Humanities, Commerce and Management, Social Sciences, Indic studies, Pharmaceutical Science, Law, Education. The open elective courses in these programs, which span across different disciplines, widen students' academic perspectives. The syllabuses of various programs were created based on input from stakeholders such as students, graduates, companies, and educators. Input: The feedback from different stakeholders as well as current trends in the rapidly evolving global trends and local/regional needs form the basis for the formulation/modification of the curricula.

To stay in tune with the current developments, the University has taken extensive measures to introduce a Choice Based Credit System (CBCS) and Learning Outcome based Curriculum Framework (LOCF) for all academic programs. The LOCF involves establishing Programme Outcomes (POS), Programme Specific Outcomes (PSOS), and Course Outcomes (COS) for all programs. The program goals have been established to ensure that the course curricula are relevant with the current times and cater to the diverse needs of the students at the local, regional, national, and global levels.

- The University's Women's Studies Research Centre (WSRC) provides an M.A. program in Women's Studies and a Postgraduate Diploma in Women's Studies. All the programs' courses focused on addressing issues related to gender.
- The majority of Science subjects' programs include a Programme Outcome (PO) related to 'Science and Society.' The impact of the ability to use logic to evaluate various societal issues and the resulting responsibilities in professional scientific work is significant for Environment and Sustainability.

have policies in place for different levels of learners

The following measures have been adopted to facilitate the learning of slow and advance learners:

- Most programs include a set of courses that allow for the recognition of both advanced and struggling students through various assessments like class tests, presentations, oral exams, projects, and final exams.
- Encouragement is given to advanced learners to engage in conferences, seminars, and summer training. They are being recommended to receive financial assistance to attend there events.
- The workshops conducted by the students instill both academic skills and self-assurance.
- Remedial Classes are organized with the objective of enhancing the academic performance of students who learn at a slower pace.
- Talented students are encouraged to engage in extracurricular activities, exhibitions, and cultural events.
- The University organizes the 'ROSTRUM- Annual Public Speaking Competition' at three levels (department, faculty, and University) to improve students' communication skills and their overall personality.
- Advanced students are assigned difficult tasks during their dissertation/project work, which greatly improves their knowledge.
- Advanced learners are urged to share their ideas in the programs hosted by the two incubation centers at the University.
- The Departments have created a system to evaluate students' learning levels and arrange programs for both slow and advanced learners.
- The centers established through RUSA 2.0 are offering diverse training programs to provide valuable experiences in different areas that can enhance the academic performance of both struggling and advanced students.
- Both university departments and the library offer induction programs to meet the needs of both slow and advanced learners.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

Learning is enhanced through student-centric activities such as group discussions, case studies, educational trips, quizzes, debates, poster making contests, and sports and cultural events.

- During theoretical lessons, instructors motivate students to explore literature/articles that are relevant to the established curriculum and present a speech/seminar in the classroom.
- The experimental component is compulsory in the syllabi of all Science and Engineering departments/institutes at the University.
- Professional programs include one semester project/training feature. In this timeframe, students must autonomously tackle a particular and clearly outlined issue within the subject area.
- Some programs offer student field training to promote participative learning among students. Students gather and examine the data independently in these field training programs.
- Many students, especially those in professional programmes, participate in summer/winter training at CSIR-labs/institutes and other organizations.
- Classroom lectures across all departments are conducted interactively, enabling students to participate in meaningful discussions, transforming the traditional classroom into a hub for enriching knowledge.
- Certain departments/institutes incorporate quizzes and group discussions into the students' participative learning experience.
- The University holds a public speaking competition called ROSTRUM in order to improve the students' communication skills and presentation abilities.
- The University arranges educational and cultural trips to educational and historical sites for the students.
- Research scholars are permitted to teach in postgraduate programs which encourages participative and interactive learning.

2.3.2 - Teachers use ICT enabled tools including online resources for effective teaching and learning processes during the year

ICT tools have enhanced the education process and support the shift from teacher-focused to student-focused teaching approaches. The following steps have been taken :

- The University campus's Wi-Fi has been upgraded with a 1GB lease line provided by the National Knowledge Network.
- In the realm of digital education, a 24x7 virtual classroom system has been implemented for engineering students at the university, allowing them to access e-lectures based on their course material.

- The essential software, such as SPSS and MATLAB, are provided for an efficient teaching and learning experience.
- The lectures of the faculty members are uploaded on the University's academic management system/LMS.

- Students are allowed to review their assessed or reassessed answer books and can also obtain photocopies of them.
- Additionally, the entire process involving receiving forms and issuing academic documents, verification, and transcripts has been automated and conducted online.
- Monitoring of the assessment of Ph.D dissertations and conferment of degrees is carried out using Ph.D database management software.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

The University has good facilities for teaching-learning in terms of Classrooms, laboratories, computers etc including smart classrooms.

- The University has excellent infrastructure for organizing conferences/seminars/workshops etc including an auditorium with capacity of 2000 persons, senate hall of 200 capacity, crush hall of 250 capacity, Faculty lounge with a capacity of 125, RK Sadan of 400 capacity.
- Every department/Institute has adequate number of classrooms, laboratories and seminar halls as per requirement of statutory bodies. There are 343 class rooms, 220 laboratories and 48 seminar halls with ICT facilities in the campus.
- Teaching and research laboratories in science departments have been continuously upgraded. An expenditure of more than Rs. 4 crores have been incurred from RUSA funds to upgrade the

teaching laboratories of the department/institutes during last five years.

- The Jawaharlal Nehru Library and Golden Jubliee reading hall of the University has a seating arrangement of about 1750 students. There is a collection of more than 4 lakh books in the University library.
- The University has provided all departments and institutes with furnished office rooms for their faculty members and administrative/ secretariat/ offices.
- Common room for boys and girls have been in most of the departments.

Kurukshetra University has prioritized sports since its inception in 1956. The University has produced numerous sports legends, including 3 Padma Shri Awardees, 16 Arjuna Awardees, 6 Dronacharya Awardees, 1 Tenzing Norgay Awardee, and 1 Major Dhyanchand Awardee.

The University's Directorate of Sports has established a professional approach to sports development. Coaching camps are organized for University teams before inter-University championships. The department sends approximately 80 teams (800 players) to participate in inter-University games and hosts 2-3 North Zone/All India inter-University championships annually.

The University offers excellent sports facilities, including a stadium, gymnasium, swimming pool, tennis court, basketball court, handball court, badminton court, volleyball court, korfball courts, hockey and football fields, shooting range, and climbing wall.

Kurukshetra University boasts a 472-acre green campus with a covered area of 367,671 square meters, providing an ideal environment for teaching, learning, and research.

- Infrastructure: The University offers excellent physical infrastructure, including teaching blocks, a central library, research laboratories, a computer center, an instrumentation center, an administrative block, deans' building, distance education directorate, examination wings, hostels, playgrounds, gyms, a swimming pool, a shooting range, an auditorium, a senate hall, a faculty lounge, RK Sadan, a senior secondary school, a construction branch, a community center, clubs, canteens, residential complexes, the Dharohar Museum (cultural heritage of Haryana), the Museum of the First War of Independence, gardens, lawns, solar panels, and a sewage treatment plant.
- Student facilities: The University provides 25 student hostels, including 13 for women, equipped with modern amenities. A health center offers 24-hour healthcare services to students, employees, and their dependents, including free medicines. A 24-hour free ambulance service is available in girls' hostels. The University provides free internal bus service to girls and physically challenged students. Ramps have been constructed in 80% of University buildings for accessibility.
- Environmental initiatives: Approximately 50 acres of land have been allocated for the Community Forest Project to cultivate medical plants, orchards, and other trees, promoting

ecological balance and a pollution-free atmosphere.

The overall campus environment is vibrant, healthy, environmentally friendly, and conducive to learning and academic activities.

Jawahar Lal Nehru (JLN) Library of the University is automated using Integrated Library Management System (ILMS) i.e. Libsys Software version 4.0. More than 4 Lakhs books are entered in the database of the ILMS and more than 10,000 members are served with the help of Libsys. The Library has various sections which are computerized with the help of ILMS. Bibliographic details of books are entered into cataloguing module and Library Members are registered using the registration module of ILMS. Online Public Access Catalogue service is provided by JLN Library to its users which enable them to search the desired books on-off campus through the web OPAC.

There is a well established computer lab in the JLN Library. It has 15000 manuscripts in digitized form. Library has the wi-fi connectivity which provides seamless access of web resources to fulfilling the academic and research requirement of the teachers and students.

There are 9 reading areas in the library with reading capacity for 1750 readers.

Presently the library is receiving 13 full text e-resources which include 8000+ e-journals under e-Shodh Sindhu consortium of INFLIBNET, in addition JLN Library subscrips Proquest Database (literature, education and psychology etc), Scifinder, Emerald and Manupatra. These all e-resources are accessible locally within the campus as well as remotely. JLN Library also has membership of Shodhganga: a PhD theses repository which has a collection of 331229 theses. It has access of NDLI, a massive electronic repository and

ESS to meet the literature needs of the users.

Kurukshetra University offers structured programs to cultivate leadership skills in its administrative and academic staff. The Executive Council, headed by the Vice Chancellor, is the governing body of the University. The Vice Chancellor also holds the positions of academic and administrative head. The Academic Council is responsible for making decisions on academic matters, considering proposals from Faculties and departmental Boards of Studies. Faculty members at the departmental level contribute to decision-making through Staff Councils, which address academic and administrative concerns. The University's decision-making process relies heavily on committees, where members deliberate and reach consensus.

The University offers eligible faculty members the opportunity to serve as Department Chairpersons for three-year terms, rotating among all faculty. Additionally, faculty members can take on leadership roles such as Deans, Directors, and Coordinators. To enhance their skills, the University provides specialized training programs. With a strength of 7990 female students out of a total of 14852, they outnumber their male counterparts in most of the academic programmes. Over the years, Kurukshetra University has earned a reputation of a calm and peaceful campus where female students feel safe to pursue their studies. This has been possible with the prevailing culture that respects the womenfolk and also the special facilities and provisions for them.

Keeping in view the security and safety of girl students, a dedicated girls' hostel complex housing 13 spacious hostels accommodating 3300 girls students. Besides having its own shopping complex, each hostel is well equipped with basic amenities.

The University has a well-established active Women's Studies Research Centre (WSRC) on the campus is successfully running P. G. diploma and M. A. in Women's Studies, covering standard womenrelated courses including of course the components of gender equity and sensitization. As a unique initiative for empowerment of women and skill development, the WSRC is arranging for six months training in Tailoring and Embroidery to the underprivileged women of villages adjoining the University. An Internal Complaints Committee against Sexual Harassment of women is fully functional with three-fold objective of prevention, prohibition, and redressal. Besides, there has been made a mandatory provision of women representation on important bodies of the University.

- The University has established procedures for managing different kinds of solid waste, such as construction waste, paper waste, plant/tree waste, and food waste. Paper waste is collected and sold to private vendors through open auctions for recycling. Biodegradable waste from plants and trees is composted on campus to create organic fertilizer, which is used to enhance soil quality in the University's lawns and gardens.
- The University has adopted and implemented the Govt. policy regarding a strict ban on the use of all items made from

single-use plastic.

- The University has its own fully functional Sewerage Treatment Plant (STP) constructed on a specially carved out sewerage farm of approximately 25 acres land and it has a capacity of 2.4 MLD.
- The University has signed MoU with a Govt. approved agency for safe disposal of biomedical waste.
- The University has devised a comprehensive policy-cumprocedure for safe disposal of E-waste material.
- Biodegradable waste from plants/trees is recycled through designated compost pits to produce organic fertilizer for meeting the fertilizer requirement of various lawns/gardens on the campus.
- Experiments conducted in the science departments involve chemicals with relatively low hazards and low-activity radioactive sources. These materials are handled and disposed of in accordance with established safety and disposal procedures. Chemicals are neutralized before disposal, and laboratories are equipped with fume hoods to control the accumulation of fumes and vapors.

Important state, regional and national festivals (like Teej, Holi, Lohri, Baisakhi, Deepawali, Christmas, Haryana day, Independence day, Republic day, National Integration day, International Yoga day, etc.) are celebrated together with great fervor which brings alive the basic national identity of "Vasudhaiva Kutumbakam".

On the occasion of Haryana day, the University organizes each year a mega state-level cultural festival "Ratnawali" to celebrate and showcase the essence of Haryanvi culture to an otherwise diverse university fraternity.

As an integral part of "International Gita Jayanti Mahotsav" organized annually by Kurukshetra Development Board, Govt. of Haryana on the banks of famous "Brahma Sarovar", the University holds on its part International Gita Seminar on relevance of Gita in different spheres of contemporary world including universal brotherhood, peace and harmony. During last few years, a galaxy of distinguished academic and spiritual scholars from different faiths have held live deliberations on such interlinked topics, and has provided a unique platform to scholars on the campus. In the year 2023, the theme of International Gita Seminar was: Vasudhaiva Kutumbakam: Srimad BhagavadaGitaand World Unity.

7.1.9 - Sensitization of students and employees of the Institution to the constitutional obligations: values, rights, duties and responsibilities of citizens

The University organizes various activities to promote awareness of

constitutional values, rights, duties, and responsibilities among students and employees. These activities include annual celebrations of important national events like Constitution Day (26th November), National Voters' Day (25 January), and National Unity Day. On National Unity Day, the University holds "run-for-unity" rallies to spread the message of national unity among the public. On National Voters' Day, students take a pledge and conduct awareness campaigns in nearby villages to encourage residents to exercise their fundamental right to vote in state, Lok Sabha, and Panchayat elections. The University also observes Anti-Terrorism Day (21st May), where students and staff take a pledge to oppose terrorism and violence, uphold peace and harmony, and combat forces that threaten human lives and values. The birth and death anniversaries of freedom fighters and distinguished persons are celebrated by offering floral tributes in which the University administration, faculty and the students participate.

Kurukshetra University established a "National Ion Beam Centre" with DST support. The state-of-the-art ion accelerator is used for materials research. The University also has a "National Lowtemperature Thermochronology" laboratory. An on-site nitrogen production plant supports various science departments. These national facilities contribute significantly to research and development in India.

b) New research centres

University has set up 5 new research centres (viz. Advanced Material Science, IT and Automation, Applied Biology in Environment Sciences, Advanced Research in Earthquake Studies, and Excellence for Research on the Saraswati River).

c) Creation of Incubation facilities

Kurukshetra University Technology Incubation Centre (KUTIC) has mentored and financially supported 20 minor projects from students.

University has constituted a Research and Development Cell (RDC) A comprehensive "Policy for Promotion of Research" has been devised to promote research eco-system and conducive environment for conducting quality research.
