

Secy. of the match(es) are allowed to engage person(s) after obtaining approval of the Secretary/Asstt. Secretary, KUSC keeping in view his/her sports achievements in the concerned game and experience in officiating.

Teams must be accompanied by the Managers along with player's eligibility particulars, Identity Cards(meant for sports purposes), authority letter, copies of Matric and D.M.C. of 10+2 duly signed/attested by the Principal/Head of the Institution. The team shall not be allowed to participate without above said documents.
4. In case of any protest during the Tournament, against any player(s)/Team(s) of a College, the Organising Secretary will arrange photograph of the player(s)/team(s), in addition to other procedure followed in case of a protest.
