NOTIFICATION

In continuation of earlier notification issued vide Endst. No. Gen/G-6 (Shopping)/2025/10302-501 dated 26.05.2025, No. Gen/Steno/2022/ 3291-3440 dated 01.07.2022 and in view of the "Sewa Pakhwada" being organized from 17 Sep, 2025 to 02 Oct, 2025, it is hereby notified again that the following action plan for Plastic Waste Management in Kurukshetra University Campus be followed strictly:


1. Complete ban on single use plastic items in KUK campus such as carry bags, plastic plates, cups, tumblers (glasses), spoons, forks, straws and all kind of disposals. Further, a regular check in the University market shops, student canteen, cafeteria etc. would be done to check the effective implementation of the ban.
2. Complete ban on plastic sachets for storing/packing or selling Gutka, Tobacco and Pan Masala.
3. Complete ban on carry bags made up of recycled plastic and containers made of recycled plastic for storing, carrying or packaging of foodstuffs.
4. Complete ban on Plastic of Polyvinyl chloride (PVC) banners less than 100 micros.
5. Complete ban on wrapping or packaging plastic films around sweet boxes and invitation cards.
6. Complete ban on burning of plastic wastes.
7. To make provision of collecting plastic bottles using wire mesh closed dustbins at appropriate places in the campus and promote generations (whose ever use plastic bottles) to use these dustbins for disposing the plastic bottles.
8. Adopt plastic items segregation system at source and further selling them to vendor periodically.
9. To create awareness among students, campus residents, shop keepers and visitors of the KUK regarding ban on plastic.
10. To promote use of carry bags made from cloth, jute or degradable material.
11. All the canteen holders/shopkeepers/booths/khokas and rehries on the University Campus are advised to shift to glass, steel and/or crockery items for serving products within one month positively after issuing of this notification failing which fine will be imposed which are as under:

Sr. No.	Quantity of prohibited variety of all type of plastic/paper items and carry bags	Amount in rupees
1.	Upto 100 gms	500/-
2.	101-500 gms	1500/-
3.	501 to 1 kg	3000/-
4.	Above 1 kg to 5 kg	10000/-
5.	Above 5 to 10 kg	20000/-
6.	More than 10 kg	25000/-

Those who fails to comply with, a fine will be imposed.
7. In charge (Sanitation), K.U.K. with the request to ensure that the dustbins be placed on proper places.
8. Director, IT Cell, KUK to upload the notification on University Website.
9. OSD to the Vice-Chancellor, K.U. Kurukshetra (for kind information of the Hon'ble Vice-Chancellor)
10. Deputy Registrar, O/o the Registrar, K.U. Kurukshetra (for kind information of the worthy Registrar)
