

Amendments/additions to Clause 7 of the General Rules for Examinations appearing at Page Number 668-669 of K.U. Calendar Volume-II, 2014 (Part B).

EXISTING	PROPOSED (w.e.f. the academic session 2025-26)
<p>7. Unless otherwise provided, a person who —</p> <p>(a) has already passed an examination of this University or any other University shall not be permitted to re-appear in that examination or a corresponding examination;</p> <p>(b) is a candidate for an examination in full subjects of this University cannot simultaneously read for, or appear at, another examination of this University or of another University/Board, in the same academic year (if otherwise stated in the Ordinance).</p> <p>The bar shall not apply to a candidate appearing in another examination of the University for passing or for improvement of division/result or for additional subject; provided that he does not take the examination in more than two subjects/papers simultaneously with the full subjects of his main examination.</p> <p>(c) is eligible to take admission as per conditions laid down in the concerned Ordinance, can pursue two academic programmes simultaneously through Distance or Open and Distance Learning (ODL)/Online mode; or upto two ODL/Online programmes or combination of distance and regular modes, from the same or different Universities/ Institutions duly approved by the UGC/ AICTE/Central Government/State Governments, in various combinations, viz;</p> <p>(1) A student can pursue two full time academic programmes in physical mode provided that in such cases, class timings for one programme do not overlap with the class timings of the other programme.</p> <p>(2) A student can pursue two academic programmes, one in full time physical mode and another in Open and Distance Learning (ODL)/Online mode; or up to two ODL/ Online programme simultaneously.</p>	<p>7. Unless otherwise provided, a person who —</p> <p>NO CHANGE</p>
