Further necessary action may please be taken accordingly.



Amendments/additions to Clause 4.7 of the Ordinance Postgraduate Programmes (Master Degrees and Postgraduate Diplomas) based on NEP-2020 w.e.f. the Session 2025-26.

EXISTING	PROPOSED <i>(w.e.f. the Session 2025-26)</i>
<p>4.7 A student having re-appear in only one course either in 5th or 6th Semester at UG level (other than the subject in which s/he wants to seek the admission in 2-year PG Programme) is eligible for provisional admission in a 2-year PG Programme in affiliated Colleges of Kurukshetra University, Kurukshetra.</p> <p>Provided further that such student will not be promoted to 3rd semester/2nd year of 2-year PG Programme, if s/he fails to pass the concerned re-appear course of the UG programme before the start of the 3rd semester/2nd year of the concerned 2-year PG programme. Such student will not be entitled neither for exit nor for PG Diploma.</p>	<p>4.7 A student having re-appear at the UG level shall be <u>eligible for provisional admission in any 2 Year PG Programme of Kurukshetra University, Kurukshetra, subject to fulfilling all other eligibility conditions, provided that seat (s) are available and no waiting list exists for admission to such programme (s).</u></p> <p>Provided further that such student will not be promoted to 3rd semester/2nd year of 2-year PG Programme, if s/he fails to pass the concerned re-appear course of the UG programme before the start of the 3rd semester/2nd year of the concerned 2-year PG programme. Such student will not be entitled neither for exit nor for PG Diploma.</p>
